**Apologies for Absence** 

Apologies were received from Maria Mekins (English Martyrs).

## 2. Purpose of meeting

CR provided a re-cap following the meeting of 25 September 2013.

DJ noted that the meeting has been called, as there were a number of concerns following the last meeting from a number of people. Concerns highlighted:

- a number of people felt there was a second proposal on the table, setting deprivation factor at 12 to 15%, as well as the proposal that was voted upon.
- Eligibility to vote, in particular the secondary representative's substitute,, and who is the nominated substitute for secondary schools.

DJ noted that the forum is an advisory panel for the local authority, and if a decision on the formula could not be reached then this would have to go to Children's Services Committee.

ML noted that he expressed concerns, as Forum need to ensure that there is consistency in voting members. Maria Mekins submitted apologies for meeting scheduled on 11 September 2013, and asked if she could send a named substitute; however, she was informed that there was insufficient time to have a nominated person in place. A secondary 'substitute' had attended and voted but was not the named substitute as one had not been agreed by secondary schools.

DJ noted that there are still anomalies around substitutes, and noted that substitutes do have voting rights as long as the substitute is a constitutionally agreed substitute. DJ noted that they had referred to the Schools Forum Regulations of 2012, which states that a substitute has voting rights, and would be expected to be involved in discussions

and feed back to the group they are representing.

## 3. School Funding Formula

DJ noted that there were two proposals on the table, however, only one was voted on. Clarification from Forum is needed on what proposal they should have voted on.

There was a proposal of looking at between 12% and 15%, however, no discussion or vote was taken on this. The previous meetings were referred to and it was confirmed that this was proposed and seconded, however, not voted upon.

At the previous meeting it was confirmed that both the lump sum would be £175,000 and ratio would remain the same.

Four models were provided for Forum to look at, and also statistical and neighbouring data was provided. Discussions took place at the previous meeting regarding Middlesbrough, as they used 15% as deprivation, and comparisons were made with their data.

Forum members have to discuss with their colleagues what was discussed at the previous meeting, then consultation will need to take place with all schools. Finance would arrange the consultation process.

Formal consultation will need to take place before the next Schools' Forum meeting on 23 October 2013. Forum need to arrive at a consensus of what is being consulted on today.

JDV proposed that consultation take place on between 12% to 15%, and this was seconded by MT. This should then give a clear steer as to what colleagues want.

The consultation would affirm that the lump sum be set at £175,000 and the ratio remain at 1:1.26. After discussion it was agreed that four models would be consulted on, 12%, 13%, 14% and 15%. Consultation materials have to be returned prior to the meeting on 16 October 2013, as this information will be used to assist Forum into agreeing the percentage of deprivation.

There will be one return per school and it is the Headteacher's responsibility to discuss with Chair of governors.

Noted that there will be an additional column added, which will give the financial loss. The sheets will be anonymised.

Consult on 4 models, all using the highest lump sum, and ratio 1:1.26. ask each school to make decision.
