

## Question M

### a) General

The following new steps have been identified by risk assessment in relation to the four Licensing objectives except as listed below.

### b) The prevention of Crime and disorder

CCTV will be installed and fully operational monitoring and recording 24 hours every day. Cameras will encompass all entrance and exit to the premises including fire exits and areas where the sale of alcohol occurs. Equipment must be maintained in good working condition be correctly time and date stamped. All recordings must be kept in date order for a period of 31 days. There must be at all times a member of staff on duty who is trained in use of equipment who can on request of a responsible Authority officer such as police, Local Authority officers or trading standards officers.

### c) Public Safety

All exit doors will be easily openable means of escape will be maintained unobstructed and clearly identifiable with emergency lighting and illuminated exit signs. All gas and electric appliances on the premises will have current safety certificates.

The premises are well ventilated by the use of in take and extractor fans. A log will be maintained of all incident or accident which may occur on the premises. An adequate and appropriate supply of first aid equipment will be available on the premises. Adequate lighting shall be in place externally in order to promote public safety.

### d) The prevention of public nuisance

Regular check by staff of the immediate outside area and to encourage patrons to use litter bin to dispose rubbish notice will be displayed all exits asking patrons to leave quietly. Display notice informing patrons the premises may be in an alcohol free zone. All litter bin shall be placed outside the building to help promote the prevention of public nuisance

### e) The protection of children from harm

A challenge 25 policy will be implemented with all staff insisting on evidence of age from any person appearing to be under 25 years of age and who is attempting to buy alcohol. All staff will be fully trained in its use before being allowed to sale alcohol. This training to be refreshed every 2 calendar month and written records kept. The premises Licence holder should ensure that a record is kept of all staff training and fully updated

The challenge 25 notices will be displayed at all points of sale and at all entrances and exits to inform customers and remaind staff that the premises is operating a Challenge 25 policy. Only valid UK photo card style driving licences, PASS approved proof of age cards Ministry of Defence form 90 indentification card or valid non expired passport are to be accepted at the premises. The business will maintain a refusals book record all instances where the sale of alcohol has been refused. This shall includes the date and time of the attempted sale, together with a discription of the incident.
