Sandy Car Park (Coach Park) is a large open space with old fairground site adjoining to the north. Situated close to the beach and not too close to residential housing, we consider it to be the ideal location to hold a music festival with the help and support of Hartlepool Borough Council. It is the intention to have one main stage (operational until 10.00 pm) erected in the south easterly corner of the site, enclosed off from public access with licensed security protecting this area, there will be a hospitality area in this area for artistes. the front and majority of car park will house visitors, toileting facilities, various vendors and licensed bars. The land to the north of this will house various fairground rides supplied and licensed by John Murphy (Headland Carnival), this will also house licensed bars and vendors (i.e. food, soft drinks, toys). All welfare facilities will be placed on main car park site in marquees. There will be a sound mixing unit at front of stage enclosed off, rear of stage will house all production equipment and generators. The whole area will be fenced off with full licensed security around the full site. As well as entrance at north west of car park we intend to have a number of emergency exits incorporated into the fencing. Capacity including staff will not exceed 4,999 people.

**We will be using fully trained security personnel (Hartlepool United Marshals).
Age and Bag checks will be carried out on visitors attending the festival.
We will be operating a zero tolerance policy.
Children must be accompanied by a responsible adult at all times. There will be a lost and found procedure in place for the duration of the event.**

Event and Music will cease at 10.00 pm, whereafter crowds will be directed to the designated festival exits.

b) The prevention of crime and disorder

Fully trained security personnel will be stationed at all entrances, exits and vip areas as well as throughout the festival grounds. We will be operating a zero tolerance policy. Anyone caught with, taking, handling or selling illegal substances will be detained by security staff and handed over to police. There will also be a rapid response security team camera equipped to deal with any eventuality. Age checks and bag checks will be carried out on people entering the festival site.

c) Public safety

**It is expected that the event for which the licence is required will be subject to a full Safety Advisory Group process and as such a full Event Safety Management Plan will be produced to address any concerns raised over public safety, identify risks to this safety and supply information and plans related to operational procedures should a threat to public safety arise. We intend to employ an independent Health and Safety Officer to carry out this task.
There will be first aid facilities on site, details will be outlined in the Event Safety Management Plan.**

d) The prevention of public nuisance

Event hours are from 11.00 am with event closing at 10.00 pm. main stage will end at 10.00 pm and crowds dispersed peacefully thereafter. Noise levels will be monitored by the on site stage and production team at the nearest noise sensitive premises and adjusted accordingly should they exceed designated and agreed levels.

e) The protection of children from harm

**All children 16 and under must be accompanied by a responsible adult at all times. I.D. and age checks will be carried out, we intend to operate a challenge 21 policy on all event bars
A lost and found childrens procedure will be outlined in the Event Safety Management Plan.
All Security and Volunteer staff will be required to have a valid CRB/DBS certificate.**
