# Hartlepool Borough Council Level 1 Strategic Flood Risk Assessment (SFRA), Level 2 SFRA and Sequential Test and Exception Test

We have reviewed the above documents and we now consider that the Publication version of the Local Plan is **sound**.

In our previous response to the Publication version of the Local Plan we found the plan to be unsound as a number of site allocations were within flood zones 2 and 3 and had not been assessed within the council's SFRA which had not been updated since 2010. We also identified that sequential and exception tests should be applied to the site allocations. The SFRA has now been updated to take account of these sites and sequential and exception tests produced. We consider that these documents have addressed our previous concerns.

We suggest the following additional minor amendments are made in respect of the submitted documents which will provide consistency between the documents but are not dependent upon our conclusion that the Local Plan is now considered to be sound.

#### **Sequential Test**

The updated sequential test describes the vulnerability classification for EMP6 as

Essential Infrastructure. However, the updated Level 2 SFRA details EMP6 as a More Vulnerable classification. We advise that the same classification is given in both documents for consistency purposes.

## **Exception Test**

The exception test details that 100% of the RC16 Seaton Front Local Centre designation area is in Flood Zone 2 and 3a. The Level 2 SFRA identifies, however, that 13% of the designation area is in Flood Zone 2 and 3a. We suggest that the figure is amended in the exception test to reflect the Level 2 SFRA.
