2. Transport Infrastructure

- (a) Are the highways mitigations identified in the work of the TVCA and HE those proposed in Policy INF2 and site specific policies?
- (b) Can the A19 grade separated junction and Elwick bypass be delivered in phases linked to the A19/A179 junction signalisation? Is the route and junction location on the Policies Map indicative?
- (c) Status and availability of the Strategic Outline Business Case for the Elwick junction and bypass?
- (d) The third link has been described as essential in creating a 'step change' in capacity of the Hartlepool road network. Have other options been investigated or transport assessments undertaken to enhance capacity or promote modal shift? Has there been a traffic model to demonstrate (i) the existing road network cannot accommodate c.1500 west of Hartlepool; (ii) the effects of the fully signalised junction at A19/A179; and (iii) the road will secure the benefits identified to highway capacity without unacceptable effects on the connecting highway in Hartlepool (for example Hart Lane/Elwick Road)?
- (e) Is the LIP estimated timeframe of work starting on the Elwick junction/bypass in 2018 and completion in 2020 reasonable? Does it have consent? Are contracts in place? Is a junction design agreed with Highways England?
