3.5 <u>Termination of Employment Costs (Brierton) £0.031m</u>

CS enquired if this was not approved would the funding need to be sought from elsewhere, SSh confirmed this, and noted that the local authority are awaiting confirmation from the EFA if historical commitments will continue or not. Previously funding for historic commitment funding has been provided every year.

Members of Schools' Forum felt that they had received contradictory information in relation to the fact that historic funding would cease / or not if forum voted against spending of certain historic funding.

MT noted that his understanding is that if Schools' Forum decide not to spend historic funding as set out in the report, and voted upon today, then would need to agree at the end of the meeting where the un-allocated historic funding would be moved to.

ZW asked if funding was used in different ways, and not how it was historically, could the funding be allocated to other priorities. Schools' Forum are not saying that they don't need the funding, or not saying that the services are not important, but are saying decisions are becoming harder, there is a need to re-align the funding where it can be best spent on the needs of young people. 6. Statutory Services provided the Local Authority (former ESG)

- 6.1 TG does not understand why funding is different between different types of schools, as set out in table 3.14 of the report. SSh believes it is down to the size of the school. If Springwell were to go academy they would receive enough funding to run the school, even with a smaller base. ZW reiterated that there could be a child in Springwell with similar needs in a mainstream school, so can't understand why the cost would be more. If a child has an EHCP plan and attends Springwell this costs more for statutory services.
- 6.2 MP noted that last year School's Forum did not release this funding back to the local authority, and a disapplication to the Secretary of State was made. The Secretary of State agreed that the local authority could not fulfil its statutory duties without this funding and granted the disapplication for 2017/18.
- 6.3 Schools' Forum voted on making the Education Services Grant (ESG) equitable across all schools at the £35 rate for the current financial year.

6.5 SEMH Update

- 6.5.1 MP had circulated notes from the previous SEMH working group meeting, and will continue to circulate notes from any of these meetings to all schools for transparency as and when the meetings happen.
- 6.5.2 TG noted that the recent press around Space to Learn has been unhelpful, as the picture in the press was that of St Hild's school and not Space to Learn.
- 6.5.3 Schools Forum noted that although they did not agree to the £60 per pupil rate it was not because of the services provided by the LA but because they did not agree that Schools should meet this from their School Budgets. This was in effect a cut to Schools Funding.
- 6.5.3 NN asked if there was any funding to available to allocate to individual schools to help with children who may go out of authority, whilst the current townwide review is happening.

MT noted that the schools capital sub-group budget has been ringfenced for the long term plans and that the decision on allocation of funding would need to be made at Schools' Forum rather than the capital group. If Schools' Forum are to make the decision then an additional meeting would need to be set up to discuss further.

SS thought that if there was any funding remaining it was allocated to supporting SEMH provision in town. NN understood that there was additional money in the schools capital budget and asked if it was possible to access some of this additional funding earlier.

6.5.4	MP noted that currently looking at final accounts for the school capital budget for the year, and there may be some underspend available, which traditionally goes back to the Schools Capital Group, however, the figure is not yet known. ZW stated that this did happen historically and the remaining budget was spent on other things, rather than being used to tackle specific schools capital projects. JHa proposed to wait until the final accounts have been prepared and the SEMH group be informed of the remaining budget, and an additional Schools' Forum be arranged for decision on the spend of this budget. MP noted that Schools' Forum has delegated responsibility for capital projects, and suggested that when a plan from the SEMH working group has been developed this is brought to a future meeting to agree the plan and see if there is some short term funding available.		
6.5.4	ZW enquired as to when the Sub Group is likely to make decisions in terms of funding allocations, as Springwell have a bid for funding for building work, and for works to be undertaken in the Easter break, a decision will be required in January 2018. The Sub Group understand that a decision is required on this.
