The agenda for Annual Council set out in the Council Procedure Rules, doesn't comply with the legislation as it only states:

xi) to **note** appointments to committees, forums and other bodies as required by the constitution

xii) to **note** appointments to joint committees.....

The law states that the appointments must be 'made' not 'noted' at the Annual Meeting, see below:

15 Duty to allocate seats to political groups.

(1)It shall be the duty of a relevant authority having power from time to time to **make** appointments to a body to which this section applies to review the representation of different political groups on that body—

(b)'where the authority hold annual meetings in pursuance of paragraph 1 of Part I of Schedule 12 to the Local Government Act 1972 (annual meeting of principal councils) and the members of the authority are divided into different political groups at the time of any such meeting, at or as soon as practicable after the meeting;'

Nature of Delegation being Exercised

Article 15 of the Constitution states that:

The Monitoring Officer is authorised to make such minor, factual, grammatical and other changes necessary to comply with legislation and statutory guidance.

Decision

To amend the wording of the Annual Meeting agenda set out in the Council procedure rules to ensure it is compliant with the law as follows:

xi) to make appointments to committees, forums and other bodies as required by the constitution

xii) to **make** appointments to joint committees.....

Reason for Decision

Ensure compliance with the legislation
