Whilst searching the premise a quantity of illegal/counterfeit cigarettes and tobacco was found of various makes. A male was arrested by officers and the goods were seized along with a quantity of money. This investigation is ongoing. It is believed that not only was illegal/counterfeit tobacco being stored at the premises but it was being sold from the premises too and with the benefit of its premises licence was able to do so until midnight.
