Supplier Relief for JR Holland Food Services in line with Procurement Policy Note 02/20:

JR Holland is the single Supplier Lot 3 (Fruit, Vegetables, Bread & Eggs) on the NEPO contract framework. Their core customer base is to public sector and they are a key supplier for Hartlepool on School Meals.

The impact of sudden and extended school closures as a result of COVID-19 has seen a big reduction in sales as demand has fallen. Without supplier relief

Jinatusia Pistosia konsul	JR Holland would need to furlough all staff and cease trading until there are enough orders to justify business operations recommencing. This would have a significant negative impact on school meals provision in Hartlepool particularly as more pupils return in mid-June. It would likely require the Council to source food provisions from alternative suppliers off contract, and almost certainly at higher prices.

Initial duediligence of JR Holland's submission has been undertaken by Stockton Borough Council on NEPO's behalf.
	NEPO will provide a collective response to the supplier for its member authorities. Eleven of the twelve NE authorities have agreed to support this proposal. The Authority which has not agreed has low spend with the company and state it has not significantly reduced during the Covid-19 period.
