Subject / Description and Reason for Decision:	<p>New lease of Seaton Common</p> <p>Following marketing of land at Seaton Common shown verged red on the plan below for grazing purposes a tender has been accepted and it is proposed to grant a new farm business tenancy on the terms set out in the Confidential Annex.</p> <p>The land, which is classified as Grade 5 (very poor) agricultural land, forms part of the Teesmouth and Cleveland Coast Site of Special Scientific Interest (SSSI) and consequently there are strict restrictions on the stocking levels allowed and also various requirements in relation to the management of the land which would not normally be imposed outside an SSSI. These factors restrict the market rental value.</p> <p>The Council receives funding through the Countryside Stewardship Agreement for various management and maintenance responsibilities.</p>

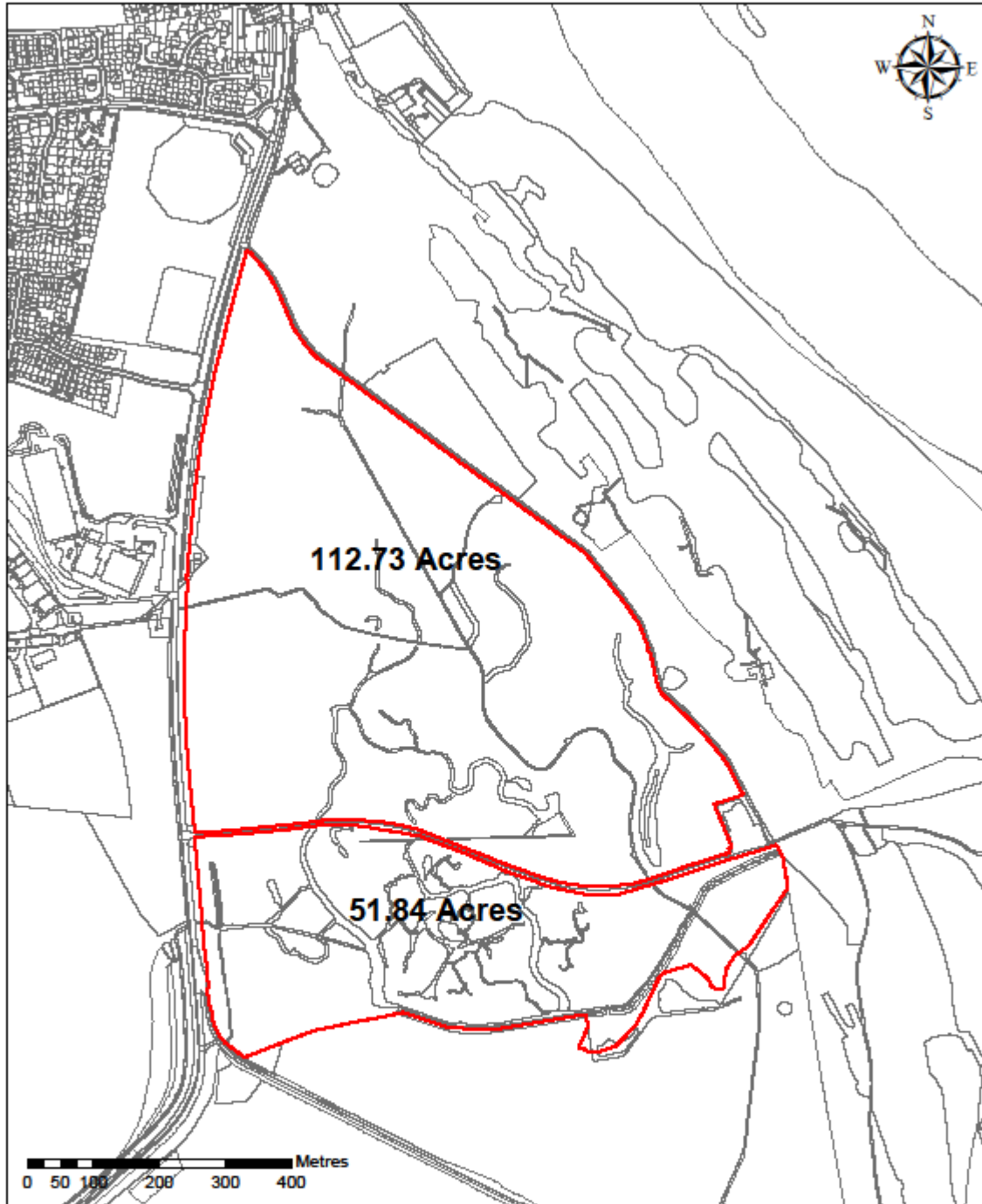
