Subject / Description & Reason for Decision:

In 2022 the Council completed an agreement for lease with the Secretary of State for Education which will facilitate the construction and operation of the new SEND Free School to be located at Golden Flatts. Full planning permission for the school was recently granted and work will begin on the access road on 20th February. The access road is to be completed prior to work on the school starting. As this will mean work on the school building starting during the bird nesting season the project will be delayed unless the school building contractor is able to go on site to carry out vegetation removal and the like (to prevent nesting occurring on the site) this month.

It is therefore proposed to grant a licence to the Secretary of State for Education which will allow the contractor (Bowmer and Kirkland) and or their subcontractor to go on site for a short period from 20<sup>th</sup> February to carry out the necessary work. They will also carry out temporary fencing of the site. As the construction of the access road is to start at the same time. access to the site will be taken from Brenda Road to avoid disruption to the road building and the health and safety issues that might arise.

The terms of the licence are in brief as follows:

Licensee: Secretary of State for Education

Licence Period: 20th February 2023 to 10th March 2023

Licence Fee: Peppercorn

Permitted Use: 1. Clearance of site vegetation to include bushes, scrub, undergrowth, hedges, trees and tree stumps not exceeding 500mm girth, including disposal of arisings.

- 3. Removal of existing chain link fence and erection of temporary fencing to site perimeter
- 4. Installation and use of temporary site access from Brenda Road including protection of services
