

Hartlepool Holiday Fun Annual Report 2022

What is the total amount of funding spent in Hartlepool under the Holiday Activities and Food Programme in 2022?

In Hartlepool we spent a total of £624,819.00 on our Holiday Activities and Food Programme in 2022. This was made up of an initial Grant of £595,500.00, and additional Grant of £29,010.00 from the Department for Education, plus £309.00 additional put forwards by Hartlepool Borough Council.

What proportion of funding was spent on administration of the programme?

A total of £59,543.00 was spent on administration for the programme which equates to 9.53% of our total funding award. This administration cost is broken down as follows:

HAF Programme Coordinator Salary = £39,529.94
Additional Administration and Management Costs = £20,013.06

How many unique children did you reach per holiday period?

Easter 2022 = 1,712 Summer 2022 = 3,688 Winter 2022 = 1,282

What was the proportion of primary to secondary age children who attended the programme in 2022?

The proportion of primary to secondary aged children works out at roughly 4:1 with a small margin for error over 2022, meaning for every secondary aged child attending there were four primary aged children.

How many children identified as SEND or additional needs have participated in the programme?

A total of 1,011 children identified as SEND or additional needs attended the programme in 2022.

Information on families and carers who have been engaged through food education, signposting and referrals aspect of the programme.

Throughout 202 our providers have worked in a variety of ways to promote food and nutrition education. This included an app which was used by providers to offer healthy food options as well as simple to follow recipes as well as using well established resources such as "Change 4 Life" and the "Healthy Plate". Some providers also offered their own food workshops within their sessions so children and families could learn basic meals they could use at home.

All providers had access to materials or support to enable them to correctly signpost and refer children and families around a range of needs from money advice to food banks, from family support to help with childcare costs. On top of this they also referred amongst themselves if a child could benefit from another provision.

All activity providers should contact parents as a matter of course where the sen/disabled child box is ticked to discuss childs needs and if they can be safely met. Alternatively on booking contact details for providers should be given to parents for them to contact providers to discuss their childs needs.

I don't think the booking system is fair. My son has autism and Pokemon is his special interest. We don't claim any benefits or DLA and he doesn't have a care plan at school as he is recently diagnosed and we have managed to support him enough that he doesn't need one. I think the current rules of not being able to book in advance unless we are on benefits or claim DLA is unfair to those of us who have children with additional needs but don't claim DLA but also those children who are mainstream who's parent work. In the summer; we missed out on a lot of weeks and when we finally got in on the last week; we were told that the places weren't even attended. This was really disappointing as my son would have loved one of those places. I would even have paid for him to attend.

The holiday activities are such a brilliant idea. My kids have attended a few now and they very much had lots of fun and always look forward to the next one.

Those events are very welcome and keep children entertained.

I would suggest that the booking system is reconsidered to take all children into account.
