

Moving your child to a different school can be stressful, affecting your child both socially and academically. It is important that you consider whether a transfer is the best option. Please read the below information before considering applying for a school transfer.

Why do you want your child to change schools?

If your request is for any of the reasons below, it is advised that the following steps should be taken before applying:

Child not attending school - Discuss with your child and the staff at the school, the reason why they do not want to attend. Explain to staff if your child is worried about anything in particular and discuss how the situation can be resolved.

To avoid exclusion - Discuss with staff at the school any reasons why your child's behaviour is non-compliant with the school's behaviour policy. Discuss with the school your child's 'Pastoral Support Plan'. If a plan is not in place, ask the school if it is possible to set one up. If your child has a plan in place, ask if it has been reviewed recently.

Special Educational Needs - Discuss the situation with the Special Educational Needs Coordinator (SENCO) at the school or if you have a query about a child with an Education Health & Care Plan, contact the Special Educational Needs/Education Health and Care (EHC) Plan team at the council. You can also get impartial advice from the Special Educational Needs & Disabilities Information, Advice and Support Service (SENDIASS). Bullying or friendship issues - All schools have an anti-bullying policy. Talk to staff at the school about how the issue can be addressed and resolved.

You have a complaint about the school or unresolved issues - Ask for a meeting at the school to discuss. If you feel your complaint has not been dealt with satisfactorily, ask the school for their complaints procedure and put your complaint in writing to the Chair of Governors at the school.

Things to consider before changing your child's school:

Teaching and school organisation - Each school teaches the National Curriculum in different ways and at different times of the year. Have you thought about how your child will cope with learning new rules and doing things in different ways?

From Year 9 onwards, children will have chosen their exam options (for GCSE) and you may find that your child is not offered the same subjects. Exam boards and course work for their chosen subjects may be different, resulting in your child possibly having to re-start coursework. Some schools also start GCSE coursework in Year 9, so your child could miss out on crucial elements.

Relationships - Your child's emotional wellbeing may be affected by moving schools, this can be a big change for a child. How will your child adjust to being in a new class, where friendship groups are already formed?

Uniform - Have you considered the cost involved for the purchase of new uniform, including full PE kit?

School travel - A change of school will usually be regarded as parental choice and as such you would be unlikely to be eligible for help with travel assistance to the preferred school. How will your child travel to the new school?

After considering the above, if you decide to apply for a school transfer, you must inform your child's Headteacher of your decision. There is no guarantee that your preferred school will be able to offer your child a place, as a high percentage of schools in the area are full, with waiting lists in operation.

Guidance notes for parents who want to apply for an in-year school transfer

BY LAW, CHILDREN AGED BETWEEN 5 AND 16 MUST RECEIVE AN EDUCATION.

This means that your child must continue to attend their current school while we process your application.

If your child has an Education, Health & Care (EHC) Plan and you wish to apply for an in-year admission, please contact the SEND Team on 01429 523553, as your child's plan will need to be reviewed accordingly.

You can list up to 3 schools on your application. You may need to supply a copy of your child's baptism certificate if you are applying for a faith school. Please refer to the school's admissions policy for guidance/more information. If you wish to apply for a school outside of Hartlepool, you will need to contact the school direct.

Before applying, please ensure that you discuss your intention with your child's current school.

In-Year school transfers usually take around 2-3 school weeks to arrange, therefore applications are processed with a view to the child starting immediately.

We recommend that you visit all school's you are interested in, before submitting your application. Visits can be arranged by contacting the school direct.

We aim to process requests within 10 school days, however this can be longer during busy periods. If there are vacancies at the schools you have asked for, we will give your child a place at the highest ranked school, which has a place available.

Please note if your child leaves a Hartlepool school which is full, it is likely that your child's place will be reallocated from a waiting list, once they start at an alternative school.

If a place is not available at your preferred school you have the right to appeal against the decision and request to go on the waiting list. If your address or circumstances change, please inform us so we can amend the details held on the waiting list. You will stay on the waiting list for a school year. At the end of the school year we will write to you to ask if you wish to remain on the waiting list for the following academic year.

Important information for Voluntary-Aided Church of England and/or Catholic schools

If you wish to apply for a Voluntary-Aided Church of England school or a Voluntary-Aided Catholic School and are applying under the faith criteria, you must fill in the supplementary information for Church Schools. This information is important, as it will allow schools to offer places in line with their admissions criteria, please also provide a copy of your child's baptism certificate with your application.

Proof of Address

The address you supply must be your permanent address at the time of application. Short-term tenancies or other arrangements entered into with the prime purpose of securing admission to a particular school will not be accepted. You may be asked to provide proof of your address.

Guardianship

The form must be completed by person(s) with parental responsibility for the child. If a child is not living with their birth parents and you are looking after the child, we need to see evidence that you are the legal guardian and have parental responsibility. Guardianship only applies if you can prove that you have full care of the child and their normal, permanent home is with you. Guardianship does not apply when taking children to / from school, or looking after them until their parents collect them. **If you cannot prove guardianship, we are unable to process the application.**
