Reason for Decision:  
(for publication) An application has been made pursuant to the Wildlife and  
Countryside Act 1981 to add a Public Footpath to the Definitive  
Map & Statement, between Speeding drive and North Sands,  
Hart Warren Dunes.

Powers of the Council under the Town & Country Planning Act  
1990, Wildlife & Countryside Act 1981 and the Highways Act  
1980 have been delegated to the Executive Director of  
Development, Neighbourhoods and Regulatory Services.

The evidence in support of the existence of this public right of  
way is compelling.

A Definitive Map Modification Order is recommended to be made  
recording the Public Footpath from Speeding Drive, Hartlepool,  
to North Sands, Hart Warren Dunes as shown on Appendix 1 –  
Plan 1, within the associated report

If no objections to the making of the order to add the claimed  
route to the Definitive Map & Statement are received, or if any  
objections which are received are subsequently withdrawn, the  
Order to be passed to the Director: Legal, Governance and  
Human Resources for confirmation;

If any objections to the making of the order to add the claimed  
route to the Definitive Map & Statement are received, and not  
subsequently withdrawn, the Order be referred to the Secretary  
of State for confirmation.

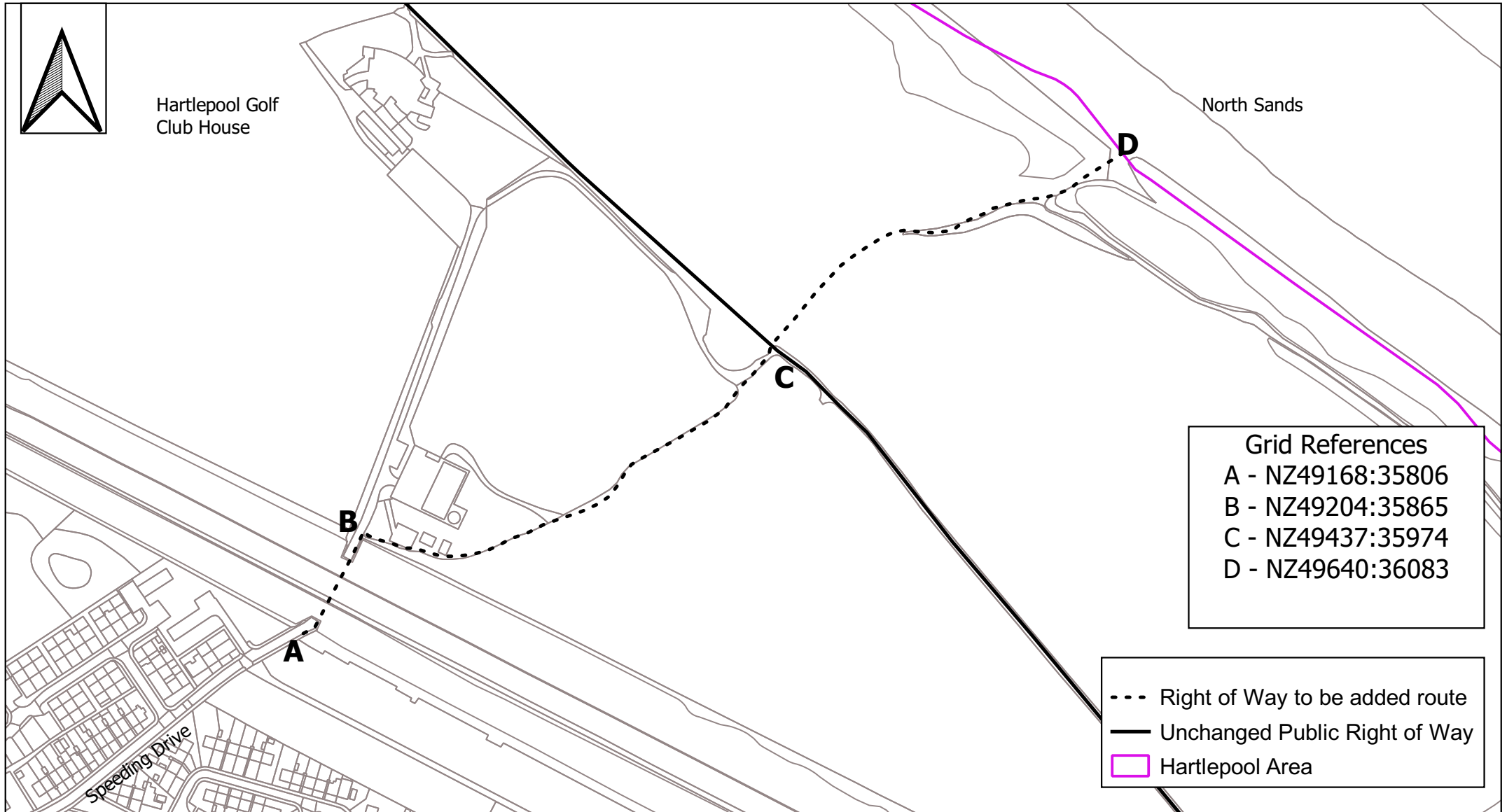
