Notes for Guidance

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable for the late night levy
2. Describe the premises. For example, the type of premises, its general situation and layout and any other information which could be relevant to the licensing objectives.  - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
 - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
 - Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the

relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

APPLICATION FOR A PREMISES LICENCE TO BE GRANTED UNDER THE LICENSING ACT 2003

Premise address: Pizza Guys, 29-31 Park Road, Hartlepool TS24 7PW

A) GENERAL – ALL FOUR LICENSING OBJECTIVES (B,C,D,E)

- The prevention of crime and disorder;
- Public safety;
- The prevention of public nuisance;
- The protection of children from harm.

B) THE PREVENTION OF CRIME AND DISORDER

In order to further reduce the impact of anti-social behaviour and to protect the local environment, the following operating schedule and previous imposed conditions will be adhered to as at present;

The application is for an existing Hot Food Takeaway with sale of alcohol by such a person as ancillary to their meal.

The prevention of Crime and Disorder

- HD Dynamic Full Colour HD quality CCTV cameras and associated Colour LED monitor; minimum of 3no. cameras positioned in the takeaway (internally) with appropriate Digital Video Recording system with date stamp with 1TB hard drive
- CCTV will continue to record 24 hours a day and will retain the footage for a period of 31 days. The recording equipment will be able to produce copied footage on a disc which will be made available on request by the police or other responsible authorities. A member of staff who can operate and make copies of the footage will always be on duty when the premise is open for business.
- An incident book will be used to record all incidents of crime and disorder
- Previous members of the public who have caused problems will not be allowed into the premises and told politely to leave the premise.
- No children under the age of 16 will be allowed into the premises unaccompanied after 9pm or be served any form of alcohol
- A proof of age scheme will be incorporated by the establishment
- A Lost Property Procedure will be carried out with the establishment
- Staff Policy will be in place to promote the duty of care for dealing with patrons suffering adversely from the effects of alcohol and victims of disorder

C) PUBLIC SAFETY

The premise meets Building regulation legislation which cover the following items;

1. Electrical
2. Building Safety
3. Fire Safety
4. Disabled persons requirement
5. Ventilation
6. Health and Safety and First Aid training will be provided to all members of staff
7. All members of staff will be trained in Fire Safety

D) THE PREVENTION OF PUBLIC NUISANCE

- Staff will be trained to communicate and respond accordingly with customers showing anti-social behaviour mannerisms in a polite and calming manner
- Staff members will clean premise thoroughly and maintain a record in writing
- No alcohol will be served to minors on premise or brought onto premise by customers.
- Staff will be trained to recognise inebriated customers and to not serve more alcohol
- Supervisor and employees will be notified where all registry documents and licence details are kept for disclosure upon request from Licence officer visiting the premise.
- Safety notices to be displayed
- The display of contact details or a direct telephone link to a private hire/taxi firm will be placed within the premise

E) THE PROTECTION OF CHILDREN FROM HARM

- No children under the age of 16 will be allowed into the premises unaccompanied after 10pm or be served any form of alcohol
- A proof of age scheme will be incorporated by the establishment - The currently accepted verification for proof of age are a passport, a photo card driving licence or an accredited proof of age scheme bearing either a holographic mark or ultraviolet feature
