*You should include here the name of your employer, the name of any firm of which you are a partner, and the name of any company of which you are a remunerated director.*

*Also anybody which has appointed you, with or without remuneration.*

#### 4. Sponsorship

The names of any persons(s) or body/bodies who have made payment or provision of any other financial benefit (other than from the Council) in respect of expenses incurred by you in carrying out your duties as a Member or towards your election expenses. #### 5. Contracts

## 6. Land

Any beneficial interest in land, which is in the area of the authority, giving the address or other description (*sufficient to identify the location*) of land.

*You should include any land in the Borough of Hartlepool in which you have a beneficial interest (that is, in which you have some proprietary interest for your own benefit). You should give the address or a brief description sufficient to identify it. If you live in the Borough you should include your home under this heading as owner, lessee, or tenant.*

*You should also include any property from which you receive rent, or of which you are the mortgagee.*

*“Land” includes any buildings or parts of buildings.*

*You should include the same information for your spouse, civil partner or cohabitee.*

## 7. Licences

## 8. Corporate Tenancies

Any tenancy where (to my knowledge) the landlord is the Council and the tenant is a body in which you or your spouse/civil partner/cohabitee has a beneficial interest.

## 9. Securities

## **IMPORTANT FURTHER GUIDANCE**

Members and co-opted Members must provide an update to the information declared within 28 days of the change.

### **Sensitive Information**

1. Where you consider that the information relating to any of your personal interests is sensitive information, and the Monitoring Officer agrees, you need not include that information when registering that interest, or as the case may be, a change to that interest.
2. You must, within 28 days of becoming aware of any change of circumstances which means that information excluded under the previous paragraph is no longer sensitive information, notify the Monitoring Officer asking that the information be included in the authority's Register of Members' Interests.
3. "Sensitive information" means information whose availability for inspection by the public creates, or is likely to create, a serious risk that you or a person who lives with you may be subjected to violence or intimidation.
