4. Sponsorship

You should show here the name of any person or body, except the Council, who has made a payment to you in respect of your election expenses or any other expenses incurred by you in the carrying out of your duties *E.g.* political party, including any payment or financial benefit from a trade union.

5. Contracts


7. Licences

You should give the address or a brief description to identify it.

"Land" includes any buildings or parts of buildings.



8. Corporate Tenancies

Any tenancy where (to my knowledge) the landlord is the Council and the tenant is a body in which you or your spouse/civil partner/cohabitee has a beneficial interest.

You should list any tenancies of property of which you are aware where the landlord is the Council, and the tenant is either a firm in which you are a partner or a company of which you are a director or in which you have a beneficial interest (as disclosed in 3 above). You should include the same information for your spouse, civil partner or cohabitee.

IMPORTANT FURTHER GUIDANCE

Members and co-opted Members must provide an update to the information declared within 28 days of the change.

Sensitive Information

- 1. Where you consider that the information relating to any of your personal interests is sensitive information, and the Monitoring Officer agrees, you need not include that information when registering that interest, or as the case may be, a change to that interest.
- 2. You must, within 28 days of becoming aware of any change of circumstances which means that information excluded under the previous paragraph is no longer sensitive information, notify the Monitoring Officer asking that the information be included in the authority's Register of Members' Interests.
- 3. "Sensitive information" means information whose availability for inspection by the public creates, or is likely to create, a serious risk that you or a person who lives with you may be subjected to violence or intimidation.
