24. Draft Children's Centre and Extended Schools Strategy (Director of Children's Services)

Type of decision

Non Key.

Purpose of report

Approval was sought to undertake a public consultation exercise on a draft Children's Centres and Extended Schools strategy.

Issue(s) for consideration by Portfolio Holder

The government's Ten Year Childcare Strategy published in December 2004 required local authorities to develop Children's Centres across the borough by 2010. Children's Centres needed to offer early education integrated with childcare, family support and outreach to parents and child and family health services.

In addition the local authority was required to ensure that a core offer for extended schools was in place by 2010. The core offer for extended schools consisted of study support activities, childcare available 8 am - 6pm, parenting support and swift and easy referral to a range of specialised support services for pupils.

The draft strategy which was attached as an appendix, set out the process

of ensuring these two requirements were met and brought together in one coherent strategy.

Three options for the proposed delivery model were included within the strategy document. The Senior Education Officer indicated that option 1 was proposed as the preferred option as it enabled local accountability through the neighbourhood fora, enabled local people to have a say on how services were shaped and enabled the extension of learning from the Sure Start programmes across the whole town.

Decision

The draft Children's Centres and Extended Schools strategy was approved for consultation.
