## Purpose of report

To provide a six month update on progress in relation to the Children's Services Department Operational Plan 2005/06 and to adopt the Children's Services Department Equality and Diversity statement as an addendum to the plan.

### Issue(s) for consideration by Portfolio Holder

The Assistant Director of Children's Services presented a report that explained the background to the Children's Services Department's Operational Plan 2005/2006. Information was given about the progress towards targets and about significant achievements during the first six months of the financial year. The subsequent review was attached by way of an appendix and demonstrated that the majority of activity scheduled by the Children's Services Department for 2005/06 were either on target or complete. A proposed Equality and Diversity statement was attached by way of an addendum to the plan. The Assistant Director of Children's Services highlighted that the first six months of this operation plan had been a very busy period for the Children's Services Department.
