31. Learning from Complaints – 1st April – 30th September 2005 (Director of Children's Services))

Purpose of report

To provide an overview of the operation of the complaints and representations procedure for Safeguarding and Specialist Services.

Issue(s) for consideration by Portfolio Holder

This report provided information on representations for the first period of 2005/2006. Fourteen complaints were active during the reporting period, a brief overview of which was provided by way of an appendix. Of the fourteen complaints received, 12 were responded to within that reporting

period and 2 were withdrawn from the framework. There were no complaints to continue into the next monitoring period.

A summary of the learning issues raised by each complaint was provided by stage of complaint in an appendix.

In conclusion, it was reported that a way towards identifying an integrated approach across the whole department had begun with the transfer of the management of complaints from the Adult and Community Services Department now almost complete.

The Mayor indicated that he was pleased to see an integrated approach being followed by the departments involved.
