Subject: PATHWAYS TO HEALTHCARE PROGRAMME: PROJECT 1 – PLANNED CARE AND PROJECT 2 – UNPLANNED CARE CONSULTATION

#### 1. PURPOSE OF REPORT

1.1 To inform Members that the Director of Strategic Service Development from the North Tees and Hartlepool NHS Trust will be in attendance at today's meeting as part of the Pathways to Healthcare consultation arrangements.

#### 2. BACKGROUND INFORMATION

- 2.1 At the meeting of the Adult and Community Services and Health Scrutiny Forum on 30 August 2007, the Director of Strategic Service Development from North Tees and Hartlepool NHS Trust delivered a presentation on the Pathways to Healthcare programme. During this meeting the timescales for this programme was outlined and it was agreed that this Forum would be involved in key milestones over the seven year development of the programme.
- 2.2 Subsequently, at the meeting of this Forum on 23 October 2007, Members approved the timetable for the involvement of the Adult and Community Services and Health Scrutiny Forum in key milestones of the Pathways to Healthcare programme.
- 2.3 Consequently, the Director of Strategic Service Development at the North Tees and Hartlepool NHS Trust will be in attendance at today's meeting to provide detailed evidence in relation to the first stage of consultation for the Pathways to Healthcare programme. The information presented at today's meeting will be delivered in the format of a presentation and will relate to:-
  - (a) <u>Project No. 1: Planned Care Emerging Outputs</u> non-emergency treatment, usually a referral from a GP, that involves been seen by a specialist which may then lead to a treatment or procedure, usually in a hospital;

(b) <u>Project No. 2: Unplanned Care – Set Up</u> – treatment provided when there is an emergency, urgent or unexpected health problem, this could be anything from a minor ailment to major trauma (e.g. traffic accident);
