TRANSPORTATION LINKS TO HOSPITAL Subject: SERVICES AND NEIGHBOURHOOD SERVICES DEPARTMENT TRANSPORT PROVISION -EVIDENCE FROM NORTH TEES AND HARTLEPOOL NHS TRUST – COVERING REPORT

1. PURPOSE OF REPORT

1.1 To inform Members that a representative from North Tees and Hartlepool NHS Trust will be in attendance to provide evidence at today's meeting in relation to this Forum's ongoing investigation into Transportation Links to Hospital Services and Neighbourhood Services Department Transportation Provision.

2. BACKGROUND INFORMATION

- 2.1 Members will recall that at the meeting of this Forum on 19 September 2007, the Terms of Reference and Potential Areas of Inquiry / Sources of Evidence for this Scrutiny investigation were approved by the Forum.
- 2.2 Consequently, a representative from North Tees and Hartlepool NHS Trust has been invited to attend today's meeting to provide evidence in relation to the Forum's investigation into Transportation Links to Hospital Services and Neighbourhood Services Department Transportation Provision.

- What accessibility planning will be carried out in relation to potential (d) hospital sites?
- What information, if any, do you provide to patients and relatives (e) seeking to access hospital services about existing transportation links to these?
- (f) How do you consider that the effectiveness of transportation links to existing, and new, hospital sites can be maximised?

1. PURPOSE OF REPORT

1.1 To inform Members that a representative from North Tees and Hartlepool Primary Care Trust (PCT) will be in attendance to provide evidence at today's meeting in relation to this Forum's ongoing investigation into Transportation Links to Hospital Services and Neighbourhood Services Department Transportation Provision.

2. BACKGROUND INFORMATION

- 2.1 Members will recall that at the meeting of this Forum on 19 September 2007, the Terms of Reference and Potential Areas of Inquiry / Sources of Evidence for this Scrutiny investigation were approved by the Forum.
- 2.2 PCTs are responsible for planning and securing health services and for improving the health of the local population. According to the Department of Health the three main functions of a Primary Care Trust are:
 - (a) Engaging with its local population to improve health and well-being;
 - (b) Commissioning a comprehensive and equitable range of high quality, responsive and efficient services, within allocated resources, across all service sectors; and
 - (c) Directly providing high quality responsive and efficient services where this gives best-value.
- 2.3 Consequently, a representative from North Tees and Hartlepool Primary Care Trust has been invited to attend today's meeting to provide evidence in relation to the Forum's investigation into Transportation Links to Hospital Services and Neighbourhood Services Department Transportation Provision.

During this evidence gathering session it is suggested that responses should be sought to the following key questions:-

- (e) What information, if any, do you provide to patients and relatives seeking to access hospital services about existing transportation links to these?
- (f) How do you consider that the effectiveness of transportation links to existing, and new, hospital sites can be maximised?
