- Subject: NORTH TEES AND HARTLEPOOL NHS TRUST -CHANGES TO THE PROVISION OF HOSPITAL SERVICES FROM 17 DECEMBER 2007: EVIDENCE FROM NORTH TEES AND HARTLEPOOL NHS TRUST – COVERING REPORT

1. PURPOSE OF REPORT

1.1 To inform Members that the Chief Executive of North Tees and Hartlepool NHS Trust will be in attendance at today's meeting to discuss the proposed changes to hospital services, mainly maternity and children's services with effect from 17 December 2007, as a result of the Independent Reconfiguration Panel's recommendations.

2. BACKGROUND INFORMATION

- 2.1 With effect from 17 December 2007, changes to hospital services are proposed by the North Tees and Hartlepool NHS Trust for maternity and children's services. In practice these changes will:-
 - (a) centralise consultant led maternity services at the University Hospital of North Tees;
 - (b) following the temporary closure of maternity services in Hartlepool to allow building work to take place as quickly as possible, open a midwife led unit at the University Hospital of Hartlepool in March 2008;
 - (c) centralise impatient paediatrics at the University Hospital of North Tees; and
 - (d) maintain paediatrics and maternity assessment units, antenatal services and children's outpatient services on both hospital sites.

- 2.2 Such changes have been brought about following the recommendations of the Independent Reconfiguration Panel. Consequently, the Chief Executive of the North Tees and Hartlepool NHS Trust has been invited to attend today's meeting to discuss the proposed changes in greater detail.
- 2.3 During such discussion, it is suggested that responses should be sought to the following key questions:-
 - (a) It is felt by this Forum that the Trust was statutorily obligated to consult this Committee on the lead-in time on the proposed substantial changes to hospital services. Why did this not occur?
 - (b) How confident are you that the residents of Hartlepool, come the 17 December 2007, will be adequately informed of such changes?
 - (c) Could you outline the steps you have taken to publicise these changes to maximise public understanding?
 - (d) How does the Trust intend to deal with those residents of Hartlepool who have not been informed of such changes from 17 December 2007 and thereafter, particularly those requiring emergency medical treatment for their child?
 - (e) What consideration has being given to the residents of Hartlepool with regard to the transport links to the University Hospital of North Tees?
 - (f) What additional community based services, if any, have been put in place prior to 17 December 2007?
 - (g) Could you outline what you understand to be your statutory obligations with regard to consultation with this Committee?

3. **RECOMMENDATIONS**

3.1 That Members note the content of the report and question the Chief Executive of North Tees and Hartlepool NHS Trust appropriately.
