3. Minutes

The minutes of the meeting held on 19 May 2008 were approved as an accurate record.

4. Employment Land Review (Planning Information Officer)

The Planning Information Officer informed Members that six tenders had been received and of these, three had been shortlisted due to the price and quality of their submissions. Nathaniel Lichfield had scored highest and therefore had been appointed as consultants to undertake stages 2 and 3 of Hartlepool's employment land review. The firm had undertaken work for other authorities in the Tees Valley. The review was necessary in order to assess the suitability of the existing sites designated as employment land and those sites no longer considered appropriate for employment use would be recommended for de-allocation. This review would be used as an evidence base for the local development framework.
