Subject: RESULTS OF TENDER FOR LONGHILL & SANDGATE BUSINESS IMPROVEMENT DISTRICT – MONITORING OF CCTV

1. PURPOSE OF REPORT

1.1 To inform members of the panel of the decision made regarding appointing contractors for undertaking the monitoring of the estate wide CCTV system for the Longhill & Sandgate Business Improvement District.

2. BACKGROUND

- 2.1 This contract is part of the overall Longhill & Sandgate Business Improvement District project that was reported to and agreed by members at the Cabinet meetings held on 11th June and 10th December 2007.
- 2.2 This contract is for providing monitoring services for the 11 camera CCTV system that is being installed on the Longhill and Sandgate Industrial Estate.
- 2.3 The CCTV camera system is being installed with funding provided from Hartlepool Borough Council, Hartlepool New Deal for Communities and Tes co through planning gain as part of their store extension.
- 2.4 The businesses on the estates have agreed via a postal ballot to set up the Business Improvement District and fund the monitoring costs of the CCTV system through a 2% levy on the rateable value of their properties payable through their rates bill.

- 2.5 The tender was advertised in the local and regional press, the Councils website and the Supply 2 website on the 1st May 2008 with quite a lot of interest received from companies.
- 2.6 All received tenders were opened at the meeting of Contract Scrutiny Panel on Monday 19th May 2008. A total of three companies submitted proposals for undertaking the study that were Housing Hartlepool, Quinn Walker Ltd and NES Services Ltd.

3. PROPOSALS

- 3.1 A Panel to score and appoint the consultants was set up that consisted of 2 members from the Longhill & Sandgate Business Association and 2 officers from the Council.
- 3.2 The tender submissions were scored on Friday 23rd May 2008 by members of this Panel and a decision was easily reached.
- 3.3 A decision was made on the basis of price (70%) and technical ability (30%) of the submissions received and the highest score achieved was 100.
- 3.4 The Panel therefore have awarded the contract to Housing Hartlepool as a result of the highest score achieved.

4. **RECOMMENDATION**

4.1 That members of the panel note the award of the monitoring of the CCTV system of the Longhill & Sandgate BID contract to Housing Hartlepool.
