# 6. The Role of the Children's Services Scrutiny Forum (Author)

The report was presented by the Scrutiny Support Officer in order to give an overview of the role and functions of Scrutiny in the Council and specifically, the Children's Services Scrutiny Forum.

The key roles of Scrutiny were detailed as:

- Policy development and review
- Holding the Executive to account
- Investigating issues of local concern

The role of Scrutiny Co-ordinating Committee was set out with a detailed description of the role and functions of the Children's Services Scrutiny Forum. The report highlighted that the strategic direction of the Scrutiny Forums was to assess, monitor and advise on the Council's progress towards the seven priority aims. The Children's Services Scrutiny Forum's remit was specifically to consider issues relating to specialist (intervention), targeted (prevention) and universal services for children and young people. A schedule of the Forum's meetings dates was also set out in the report and Members were asked to note that all scheduled meetings would commence at 4.30 pm to enable the young people's representatives to be in attendance.

Beth Hawkridge introduced a number of young people who were interested in becoming the Young Persons' representatives on the Forum and would be chosen from the following categories:-

2 Young Voices2 Looked after Children2 School Councils Forum (from 7 secondary schools in Hartlepool)

The Scrutiny Manager and Director of Children's Services agreed to clarify the situation with regards to the co-opted member vacancies that existed on the Forum.

A query was raised as to who made decisions regarding the Schools Transformation Programme and it was clarified that decisions on school transformation were made through the Project Board which was chaired by the Children's Services Portfolio Holder. Democratic accountability was via the Portfolio Holder and/or Cabinet depending on the decision and the degree of consensus. Because of the often tight government timescales in relation to Building Schools for the Future and the Primary Capital Programme, Scrutiny was represented on the Project Board through the Chair of the Children's Scrutiny Forum, Chair of Neighbourhood Scrutiny Forum and the Chair of Scrutiny Co-ordinating Committee. The Chair confirmed that there were time constraints with regard to the Government programmes but it was important that people were allowed to voice opinions on what was best for the people of Hartlepool. The Director of Children's Services encouraged Scrutiny members to take the opportunity to take part in the forthcoming Primary Capital Programme consultation process.

#### Decision

The report was noted.

## 7. Appointment to Outside Bodies (Assistant Chief Executive)

The Democratic Services Officer presented the report which sought Councillor nominations to Outside Bodies referred to the Scrutiny Forum by the Executive. In this instance 5 members to the Schools Admissions Forum were required.

Nominations had been received from Councillors Fleet, Griffin and Simmons (Labour) and Councillor A Lilley (Administrative Group) and were agreed at Annual Council therefore one further nomination was required. Since Annual Council, the Administrative Group had notified Democratic Services of a change in their nomination to the Children's Services Scrutiny Forum to Councillor Plant and consequently a further nomination was required.

#### Decision

The nominations agreed at Annual Council on 22 May 2008 to the School Admission Forum of Councillors Fleet, Griffin and Simmons were confirmed.

Councillors London and McKenna were nominated as members of the School Admission Forum subject to the approval by the Executive.

The Director of Children's Services, the Portfolio Holder for Children's Services and the Chair of the Forum had already met to suggest suitable topics for the Forum to consider and these were outlined on page 2 of the report. It was suggested that a maximum of two items should be chosen for

#### Decision

### 10. Consideration of Progress Reports/Budget and Policy Framework Documents - Children and Young People's Plan 2009 – 2012 (Director of Children's Services)

The Partner and Integration Development Manager presented a report which provided an outline of the consultation process for the re-writing of the current Children and Young People's Plan in preparation for the publication of the new version in April 2009.

The Local Authority was required to produce a Children's and Young People's Plan under Section 17 of the Children Act 2004 and the Children and Young People's Plan (England) (Amendment) Regulations 2007.

The existing Children and Young People's Plan 2006 – 2009 required review and updating to meet new requirements on Children's Services departments and their partners.

The plan was updated year on year and a summary version had been designed by Young People and consultation was currently taking place in order that the new plan reflected a wide range of views. There were to be different stages of consultation, involving the impact of the current plan, what improvements were necessary and then the formulation of a new plan which would be put out for consultation to ensure that this was acceptable. When the plan had been approved there would be a built in programme of constant consultation so that there would not be the need to review the plan again in three years time.

The Chair suggested that consultations should take account of the split of the town into the North, Central and South areas and it was important to ensure that all areas were covered during consultation events.

A reference group was sought to liaise with officers working on the plan to check and challenge processes as the Children and Young People's Plan was

Subject: SCRUTINY INVESTIGATION INTO HARTLEPOOL BOROUGH COUNCIL'S FOSTER CARE SERVICE – SCOPING REPORT

#### 1. PURPOSE OF REPORT

1.1 To make proposals to Members of the Children's Services Scrutiny Forum for their forthcoming investigation into 'Hartlepool Borough Council's Foster Care Service'.

#### 2. BACKGROUND INFORMATION

- 2.1 At the meeting of this Forum on 16 June 2008 Members determined their Work Programme for the 2008/09 Municipal Year. The topic of 'Foster Care' was selected as the first Scrutiny topic for consideration during the current Municipal Year. Furthermore, Members suggested that this investigation should form the major in-depth Scrutiny Inquiry for the Forum's 2008/09 work programme. Members also suggested that the Scrutiny topic should consider issues around areas of 'kinship' and 'guardianship' carers.
- 2.2 Under the Care Standards Act 2000, Ofsted inspected Hartlepool Borough Council's Fostering Agency on 10 August 2007 and with reference to the Children Act 2004 reported that "the overall quality rating is good<sup>1</sup>"; where 'good' is defined as meaning that "the provision is strong<sup>2</sup>".

#### 3. OVERALL AIM OF THE SCRUTINY INVESTIGATION

3.1 To review Hartlepool Borough Council's recruitment and retention activity in relation to Foster Carers, including the provision of guidance and support to foster, kinship and special guardianship carers.

## 4. PROPOSED TERMS OF REFERENCE FOR THE SCRUTINY INVESTIGATION/ENQUIRY

- 4.1 The following Terms of Reference for the investigation are proposed:-
  - (a) To gain an understanding of the role and responsibility of Hartlepool Borough Council's Fostering Service.
  - (b) To assess the marketing campaign targeted at potential foster carers who are 'new' to the Authority;
  - (c) To compare the recruitment and retention rates in Hartlepool Borough Council's Fostering Service both locally and nationally, drawing on models of best practice;
  - (d) To examine the Fostering Service's placement strategy with specific reference to the following areas:-
    - (i) The use and role of Independent Foster Agencies;
    - (ii) The level of support and advice provided to foster carers; and
    - (iii) Comparison of remuneration levels for foster carers locally and nationally.
  - (e) To investigate the provision of support to kinship carers and compare its equability to Hartlepool Borough Council's foster carers; and
  - (f) To review the Authority's implementation of special guardianship arrangements.

#### 5. POTENTIAL AREAS OF ENQUIRY / SOURCES OF EVIDENCE

- 5.1 Members of the Forum can request a range of evidential and comparative information throughout the Scrutiny review.
- 5.2 The Forum can invite a variety of people to attend to assist in the forming of a balanced and focused range of recommendations as follows:-
  - (a) Portfolio Holder for Children's Services;
  - (b) Children's Services Department Officers;
  - (c) Independent Fostering Agencies;
  - (d) Foster Carers;
  - (e) Neighbouring Local Authorities;
  - (f) Ward Councillors;
  - (g) Local residents;

- (h) Neighbourhood Consultative Forums; and
- (i) Representatives of minority communities of interest or heritage.
- 5.3 The Forum may also wish to refer to a variety of documentary / internet sources, key suggestions are as highlighted below:-

#### 6. COMMUNITY ENGAGEMENT

- 6.1 Community engagement plays a crucial role in the Scrutiny process and paragraph 5.2, details who the Forum could involve. However, thought will need to be given to the structure in the way that the Forum wishes to encourage those views.
- 6.2 In addition, diversity issues have been considered in the background research for this enquiry under the Equality Standards for Local Government. As such the views of local diversity groups will be sought throughout the inquiry where felt appropriate and time allows. Consequently, consideration has been given as to how the views of people from minority communities of interest or heritage (for example, people with disabilities, people with learning disabilities, people with mental health problems, black and minority ethnic people, and Lesbian, Gay, Bisexual and Transgender people), which may not be gathered through the usual community engagement routes, can be included over the course of the inquiry.

# 7. REQUEST FOR FUNDING FROM THE DEDICATED OVERVIEW AND SCRUTINY BUDGET

#### Option 1

- 7.1 Consideration has been given, through the background research for this scoping report, to the need to request funding from the dedicated Overview and Scrutiny budget to aid Members in their enquiry. At this stage no additional funding has been identified as being necessary to support Members in their investigation. Members, however, may wish to seek additional funding over the course of the investigation and the pro forma attached at **Appendix A** outlines the criteria on which a request to Scrutiny Co-ordinating Committee will be judged.
- 7.2 In addition, it is possible that over the course of this investigation some specialist research / advice may strengthen the Forum's findings and recommendations. The Scrutiny Support Officer will explore this in greater

Members' comments would be welcomed at this stage in relation to requests for additional funding from the dedicated Overview and Scrutiny Budget.

- (ii) A presentation/report on the foster care placement strategy, gathering evidence from the following:-
  - An Independent Foster Agency; and
  - Individual Foster Carers.
- w/c 20 October Visit to Local Authority to draw on examples of good practice in relation to recruitment, retention and marketing of foster carers.
- 11 November 2008 Formal meeting of the Forum to receive:-
  - A presentation/report on the support for kinship carers in comparison to the level of advice/guidance provided to foster carers within Hartlepool Borough Council;
  - (ii) A presentation/report on the implementation of special guardianship arrangements by Hartlepool Borough Council; and
  - (iii) Feedback from visit to Local Authority.
