1.0 PURPOSE OF REPORT

1.1 To request the Portfolio Holder's confirmation of the decision to waive standing orders in respect of the procurement of mobile classrooms for English Martyrs R.C. School and Catcote School.

2.0 BACKGROUND

- 2.1 As part of the dosure of Brierton School it had been identified that the remaining comprehensive schools would need additional (capacity) class room space to accommodate the extra pupils that they need to take during the Schools Transformation Programme. As part of this process each school was consulted.
- 2.2 The uplifting of the five existing mobiles from Brierton and their repositioning at other school sites is also being carried out as part of this process during the summer holidays.
- 2.3 Mobile units have already been installed at Manor College and Springwell School as they both identified an immediate need for additional accommodation.
- 2.4 In respect of English Martyrs R.C. School and Catcote School seven leading suppliers were contacted in June 08 to discuss delivery timescales and all expressed a desire to be included on the tender list. The tenders have since been sent out and all of the aforementioned suppliers have now declined to tender because of the increased demand for new units.
- 2.5 Wernicks Hire have however been able to provide us with an alternative solution that will meet the tight timescale required. The units need to be in position for September 2008. They have confirmed that they have in stock refurbished units that can be adjusted to suit the requirements of both schools. However the company advised us that in order to secure the units an order would need to be placed almost immediately.
- 2.6 Under normal circumstances we would be required to invite tenders in accordance with the Contract Procedure Rules. In this event we would

not be able to meet the schools tight timescales and therefore Standing Orders need to be waived in this instance.

3.0 PROPOSALS

- 3.1 An order has been placed as required to secure the mobiles and delivery agreed.
- 3.2 All enabling works (paths and services etc.) have been procured separately via the strategic partnership and will be completed in time to receive the said units.
- 3.3 The units will be checked for quality by our architectural staff who will ensure that they are fit for purpose when complete.

4.0 FINANCIAL IMPLICATIONS.

4.1 Quotations have been received for supply delivery and erection of the units in the sum of £263,986 for Catcote School and £96,802 for English Martyrs R.C. School. These costs have been checked by our Quantity Surveyors to ensure value for money and were found to be within the limits we would expect for mobiles of this size.

5.0 **RECOMMENDATIONS**

5.1 That the Portfolio Holder confirms the decision to waive standing orders in respect of the procurement of mobile dassrooms for English Martyrs R.C. School and Catcote School.
