# **44.** Local Involvement Networks (Senior Procurement and Support Officer)

The report was presented to inform the Panel of the decision made regarding the appointment of the Host organisation for Hartlepool's Local Involvement Network.

Invitations to tender had been issued to seven companies who had expressed an interest in providing the service but only two tenders had been received from Hartlepool Voluntary Development Agency (HVDA) and Shaw Trust. These had been opened at the Panel on 30 June 2008. Both companies had been interviewed and scored based on price (30%) and quality (70%). The quality element included a written submission, presentation and interview.

### **Decision**

The Panel noted the decision to select HVDA as Host for Hartlepool's Local Involvement Network to March 2011.
