### **18. UPDATES AND MATTERS ARISING**

### **Railway Bridge Pigeon Problem -**

Councillors and residents advised that the problem is even worse as there are now dead pigeons in the net. The problem would be considered when the walkabout with the Director. KO to note.

### **Bruntoft Avenue Gates onto** allotments still left open - An

Enforcement Officer said new locks/keys had been ordered. This would also be looked at on walk-about with the Director. KO to note.

### **Bollards missing at Thorpe Street**

entrance to beach - K O said these had been removed for some sea defence works to be done and would be put back in September.

Broad Field Road request for something to be done about parking at Carnival time as residents not able to get near their homes- can be looked at for

next year - include in overall discussions on parking at the Headland.

### **19. PUBLIC QUESTION TIME**

Correct Signage near hospital still not in place - PM noted and said should be erected soon.

Six Issues relating to highways / traffic / road safety issues were raised on questions/comments forms by a resident (RT) - all the issues were read out and noted by the Chair and passed to the Acting Head of Technical Services (Nick Clennett) who would arrange for officers to liaise direct. In relation to one of the issues raised Cllr Peter Jackson commented that enforcement was urgently needed outside the shops (Wiltshire Way area).

Bunting Close - Residents raised issues of break-ins in gardens etc, and the area near the fence that needed dealing with (strimming etc). The Caretaker at **Throston Grange Community Centre** (Chris) raised the issue of growth like jungle near her property and Councillors agreed there is a problem. KO indicated she had arranged for a walk-about on site with residents, Officers and Colin Stainthorp

Bunting Close - Sign needed to their bungalows, ie "Leading to Bunting Close etc". Residents said this had been requested 18 months ago - Noted by KO.

### Voting Issues - Bunting Close area -

residents complained that some people in the area had been unable to vote. The split of numbers and venue seemed unsuitable. They asked that something be done for next time. Noted by KO and Ward Councillor PJ.

Bunting Close residents also raised the Tees Valley Housing road issue - KO

agreed to include this area in the walkabout.

Traffic Lights near King Oswy School not working again. PM advised of situation and agreed to take further action.

**Brancepeth Walk signage** - PM noted - had been on order - would investigate further.

Members of Public asked about the possibility of an alleygate at Spearman Walk garages - Anthony Scarre from Housing Hartlepool indicated that he would look at this request again.

### 20. ANNUAL LIBRARY PLAN 2005/06

The Forum received a detailed report and a copy of the draft Annual Library Plan 2005/06. The Forum was advised that the Plan, as part of the Budget and Policy Framework of the Council, is required to allow examination of the service and its development. The four linked parts of the Plan and the Public Library Service Standards were described in detail and the Action Plan for 2005-08 was attached as an appendix to the Plan.

The Borough Librarian indicated that as part of the planning process, consultation with the public is required. This year the consultation is around the subject of the Impact Measures and how the work of the public libraries relates to and improves the other agendas of local and central government. This was taking place through contacting key stakeholders and library users.

The Forum was requested to consider whether current plan meets the needs of the public and the requirements of performance management. Because of time constraints at the forum the Borough Librarian asked that anyone wishing to comment or raise issues should contact her by telephone on 523016, by e.mail on susan.atkinson@hartlepool.gov.uk or by writing to her at The Central Library, York Road.

The Chair thanked the Borough Librarian for her report.

### 21. INSPECTOR'S REPORT INTO OBJECTIONS TO THE HARTLEPOOL LOCAL PLAN -PRESENTATION

The Assistant Director (Planning and Economic Development), presented a detailed report, inviting comment on the recommendations made by the Inspector following the Public Local Inquiry into objections to the Hartlepool Local Plan. The report and appendix:

- set out the background leading up to the Public Local Inquiry;
- identified the main issues arising from the recommendations contained in the Inspector's Report on objections to the Local plan;
- summarised proposed responses to the Inspector's recommendations relating to the main issues; and
- highlighted the next stages in the plan preparation process.

Of specific interest in relation to the North area were the Inspector's recommendations relating to:

- The Victoria Harbour development;
- Some of the alternative housing sites suggested in objections for inclusion in the plan, ie (a) a westward extension of Middle Warren, (b) land adjacent to the Raby Arms at Hart, (c) land at High Throston gold course, and (4) land at the General Hospital., and

• Developer contributions for housing regeneration.

In addition to the detailed report, the Assistant Director (Planning and Economic Development) dave а presentation, explaining each slide and updating on the current position. The next stages were also detailed in the report and presentation and the Assistant Director asked for comments on the Inspector's recommendations, the proposed responses to these and the resultant modifications to the Local Plan. He indicated that issues could be raised direct by telephone, by e.mail to stuart.green@hartlepool.gov.uk or in correspondence to the him at Bryan Hanson House.

During discussion the following issues / Questions arose:

(a) Possible proposals for 53 two-storey houses in the Sedgewick Close area - A Res Rep (MP) mentioned the flooding problems and the demolition of bungalows in this area and asked how new build could be undertaken in the circumstances. The Assistant Director the advised of planning process undertaken following an application and the liaison and requirements in relation to Water Northumbrian Limited and proposed developers.

(b) The need for green spaces for children to play was stressed by residentsThe Assistant Director advised that the Plan did include a policy relating to this.

(c) A Councillor referred to the Inspector's comments on planning gain and asked that where "planning gain" is achieved then local people should be able to decide what this is used for - he asked for Cabinet to include provision for this in the Local Plan. (d) On Briarfields - A Councillor (JM) commented that he and other Councillors had expressed the view that the land should be given back to those who had allotments; such areas are needed and if the possible sale of the land is about money only then it should be taken out of the Plan; He also said that if HBC do receive money for the site he would like to know what happens with it.

(e) Residents asked what was to happen with St Hilds land - The Assistant Director said this was being investigated. Ward Councillors had concerns that if it's just left it would worsen and the view for those entering town from the North by train would be even worse.

(f) Resident asked if tests were being undertaken on the Victoria Harbour site in relation to contamination -The Assistant Director advised that investigations had been carried out and that any planning permission would include appropriate conditions to deal with contamination issues.

(g) A Res Rep (JL) commented on the Regional Spatial Strategy. The Assistant Director advised that HBC were not proposing any other outward developments of the town.

(h) Old Steetley Magnesite area - A Councillor asked what development was proposed. The Assistant Director advised that a planning application had been received - a whole range of issues need to be completed and consultation would be undertaken.

The Chairman thanked the Assistant Director for the presentation and for answering questions.

### 22. WINTER SERVICE PLAN

The Highways Services Manager, Paul Mitchinson, (PM), presented a report which detailed the Winter Service Policy and Priorities, the objectives and statutory basis, the limitations, the current position and recommendations.

A short presentation was also given and PM advised that the purpose of consultation was to get the views of the public to enable him to prepare 4 documents:

- (i) Policy Document.
- (ii) Decision making requirements.
- Service delivery details. (iii)
- Information leaflet for members (iv) of the public.

PM indicated that he would listen to peoples concerns and any suggestions, before the end of the current month to allow him time to finalise his plans.

A request was made by a Councillor for information to be put out on Radio Cleveland or Hartlepool Radio, daily saying where bad areas are.

The Chairman thanked Paul for the presentation and asked residents to get in touch with any comments (contact details on report).

### 23. DECRIMINALISATION -PRESENTATION

The Acting Head of Technical Services, Nick Clennett, and Car Parking Manager. Phil Hepburn, gave a presentation on Decriminalised Parking Enforcement (DPE), which covered the following:

- What DPE is:

- What will the introduction of DPE mean;
- Why have we introduced DPE •

Officers explained each of the slides in detail and gave the up-to-date position.

During discussion the following issues were raised:

A Councillor commented that schools should be a priority area but Church areas should be looked at, particularly Holy Trinity, Davison Drive - she had been asking for 26 years for one side of the road to have yellow line and problems still occurred.

A resident reported that some signage in no parking areas needed renewing. NC said this was being done throughout town.

Everyone welcomed the new arrangements and awaited more stringent enforcement in those areas previously raised by the Forum, ie schools, footpaths and cycleways and on yellow lines in general.

### 24. UPDATE OF GRAYFIELDS **DEVELOPMENT - PRESENTATION**

James Gilchrist gave update an presentation and indicated that funding was in place and work on the Pavilion would start in November.

The following questions/comments arose:

Gates near Salisbury Place are sometimes left open all night and people are in Grayfields, drinking etc. - JC said he was aware and had raised the issue with Security. - a turnstyle at top had been discussed this was a possible option.

A resident asked if the athletics track would be renewed. JC advised that consultation with users had indicated that the track being developed at High Tunstall would be preferable - hence improvements at Grayfields had not been included in the plans.

### 25. FRIENDS OF SPION KOP -PRESENTATION

Withdrawn until next meeting.

### 26. PRIMARY CARE TRUST UPDATE -PRESENTATION

Kevin Aston, the Patient and Public Involvement Officer from the Hartlepool Primary Care Trust (PCT) gave a presentation on the Summary of the Report by Professor Sir Ara Darzi on the Acute Services Review in Teesside. A copy of the presentation was also circulated and Kevin spoke on each slide giving any other relevant information and an update. The future process and timetable were outlined.

Kevin advised that he would feed any comments/views of local people back into the Review and bring an updated version back to a later meeting of the Forum.

The Chairman, Councillors and Forum welcomed the outcome of the Review to date but were aware that the fight was not over.

On the subject of the Joint Committee of PCTs that had been set up to organise consultation and make decisions on the Tees Review - comments were made

from the Forum that the meetings of this group should not be held behind closed doors. Also concern was expressed about the Group being chaired by Middlesbrough (with possibility of second vote of the Chair), and the possible Vice-Chair being from Stockton. A Res Rep advised that she understood the PPI Forums were already planning to put in a complaint.

It was agreed that a letter should go from this Forum detailing its concerns.

A resident complained strongly about the loss of Emergency and Trauma Services as she felt this would add even more stress to patients and relatives etc.

On the issue of getting an ambulance at emergency times - The Chairman and a Resident Rep reported on long delays and bureaucracy experienced by them.

Kevin indicated that he would bring a further report to the Forum on the Review.

### **27. NORTH HARTLEPOOL** PARTNERSHIP (SRB)

The North Hartlepool Partnership Manager, John Ford, provided a report detailed project updates on the following:

The Forum noted the report.

The Forum received a report detailing proposals for schemes to be funded from the Forum's Minor Works Budget.

These were as follows:

- Scheme 3 Ridlington Way garages;

- Scheme 7 Throston Community Centre;
- Scheme 8 West View Road crossing and Middleton Road crossing;
- Scheme 9 King Oswy Roundabout -Painting. (raised under Any other Business and report circulated at the Forum.

A Res Rep raised the Middleton Road crossing and asked that this be advanced up the list. Noted by DS

Any match funding areas were detailed in the report.

Discussion took place and the following **Decision** was agreed:

Scheme 1 Refused Scheme 2 Defer for breakdown of costs Schemes 3 to 9 Agreed for recommendations to the Portfolio Holder.

Crossing Cleveland Road - A Res Rep remarked that there had been no mention on Agenda - a site visit had taken place and he asked what is happening. This was noted by KO and PM for future report to the Forum.

A resident advised that the area near footpath Phoenix Close needs chicane -(end of Otterpool Close). KO agreed to investigate.

### Subject: NORTH HARTLEPOOL PARTNERSHIP PROGRAMME UPDATE

### 1. PURPOSE OF REPORT

1.1 To update the Forum on progress relating to activities and project development by the North Hartlepool Partnership.

### 2. **PROJECT UPDATE**

- 2.1 Details of progress on the main environmental and community based capital projects are as follows:
- 2.2 Street Lighting

In the current financial year street lighting improvements are planned for The Lawns, Moor terrace, Darlington Street and Union Street.

### 2.3 Closed Circuit Camera

It is proposed to install a CCTV camera to cover Spion Kop. The exact siting of the camera is subject to technical evaluation, statutory planning processes and consultation with statutory bodies and local residents.

### 2.2 Headland Environmental Improvement Programme

The scheme is aimed at the environmental and economic regeneration of the Headland.

Completed schemes include environmental improvements to the lower promenade at the Fish Sands and provision of sculptural seating at the Paddling Pool. 18 Story Trail columns on a circular route around the Headland are to be installed shortly.

Further consultation on the Town Square was undertaken in August at the Borough Buildings. Interested people were invited to attend to give their views. At the event people were able to take a "virtual tour" of the planned square and history garden with the help of computer generated images. As part of the event, residents were asked their preferred choice of location of a new bus waiting area as part of the improvements. The majority of those who responded with a specific preference said they favoured a bus waiting area on Durham Street and a single lay-by on Middlegate. Based on this consultation, this option has been approved by Hartlepool Borough Council.

### 2.3 Carnegie

Work continues on site. Completion target is still October 2005.

2.4 Friarage Demolition

> Work is underway on the demolition of the derelict buildings near the Friarage Manor House.
