

EVIDENCE FROM VIEWPOINT SURVEY

#### 1. PURPOSE OF REPORT

1.1 To provide evidence to the Forum of the results of the Viewpoint Survey into Foster Caring that was carried out in April 2006.

#### 2. BACKGROUND INFORMATION

- 2.1 Viewpoint, Hartlepool Borough Council's Citizens' Panel, is one of the ways that the Council consults and involves local people in the governance of Hartlepool. It is a statistically balanced panel of local people who receive questionnaires at regular intervals throughout the year, asking for their view on a variety of local issues facing the Council and Hartlepool as a whole.
- 2.2 The aims of the survey are:-
  - (i) To listen to the community;
  - (ii) To involve local people in the Council's decisions and in its policy, planning and reviews;
  - (iii) To consult the panel regularly on important local issues; and
  - (iv) To discover what are the community priorities for future Council activities.
- 2.3 This report details the results for the Viewpoint questionnaire, which was distributed in April 2006 too all active panel members. A response rate of 70.9% (864 completed questionnaires) was achieved.
- 2.4 The April 2006 (number 19) Viewpoint Survey also included questions on the internet and you, preparing for emergencies and community strategy.

#### 3. SURVEY RESULTS

- 3.1 The Viewpoint survey included eight questions relating to Foster Caring, the results of which are attached as **Appendix A** to this Report.
- 3.2 The vast majority of respondents were not aware of how to become a foster carer and what help, training and support there was for carers.
- 3.3 Less than a quarter of respondents around April 2006 had seen or heard advertising, information or articles relating to foster caring. Of these 195 respondents over half had seen or heard of foster caring through the local newspaper and television.
- 3.4 Articles in the local magazines and newspapers, leaflets through doors and posters around Hartlepool seemed to be the most likely way for foster caring to be broadcast to those respondents of the Viewpoint survey. Although just under half of respondents thought that Hartbeat, local radio and the Council's internet site might also be successful mediums.

#### 4. RECOMMENDATIONS

4.1 That Members consider the issues raised in the Viewpoint survey carried out in April 2006.

# Investigation into Hartlepool Borough Council's Foster Care Service

As part if the evidence gathering process, Members of the Forum visited the Darlington Borough Council.

The findings of Members of the Forum who undertook the visit were as follows:-

- Although Darlington Borough Council remunerates their Foster Carers at the same level as Hartlepool (in line with the Fostering Network minimum rate) the fee payment scheme is at a much lower level.
- Darlington Borough Council has specific problems recruiting Foster Carers for the older teenager, which is in line with national trends.
- Possibly due to the lower fee payment scheme in Darlington, they have recently lost one Foster Carer to an Independent Foster Agency.
- Training is an issue for Foster Carers in Darlington as the Council tries to fit sessions around working families. Remuneration of Foster Carers in Darlington has engendered a theory that the Council cannot be prescriptive about when training session are run, unlike the Independent Foster Agencies where Foster Caring, in financial terms, can be seen as a career.
- There are currently only three kinship carers at Darlington Borough Council.
- Family Group Conferencing is currently operating in Darlington after a very successful pilot. This has been one of the reasons for a reduction in kinship carer numbers.
- The ratio of Foster Carers to Support Workers is 15:1, although currently due to long-term sickness that ratio is 18:1.
- Darlington Borough Council hold three training sessions a year meaning that potentially new Foster Carers only have a potential maximum of four

months between expressing an interest in training and starting their foster care training.

- 35-38% of looked after children in Darlington are in the 0-4 age range.
- During 2007 Darlington Borough Council had 66 people registering an interest in becoming a foster carer; this resulted in a conversion rate of 9 fully trained foster carers. During the same period Darlington Borough Council lost 8 foster carers, due to a variety of reasons.
- Darlington Borough Council currently has a very stable team. Made up of one manager, one administrator, one support officer and four social workers.

# <u>Children's Services Scrutiny Forum's Investigation into</u> <u>Hartlepool Borough Council's Foster Care Service</u>

Responses from staff who work for Hartlepool Borough Council's Foster Care Service.

1. What are the strengths and weaknesses of Hartlepool Borough Council's Foster Care Service?

### Strengths

- Supervising social workers are dedicated.
- Well qualified and experienced staff.
- Thorough and rigorous assessment of prospective foster carers.
- Good level of support to approved carers.
- Post approval training of carers.
- Effective fostering panel who are committed to their task.
- Carers are able to progress through the Carers Progression Payment Scheme.

#### Weaknesses

- Little staff training for working with foster carers or for the carers.
- Lack of clear direction, support and staff supervision.
- Very few clear guidelines or procedures.

- 2. What changes (if any) would you like to see to Hartlepool's Foster Care Service?
  - Flexible working arrangements to meet the needs of the carers and staff.
  - Staffing level increased to reflect the numbers of carers supported and the myriad of tasks carried out everyday.
  - Systems in place to allow workers to be more efficient.
  - Increased administrative support.
- 3. Do you have any thoughts about how Hartlepool might improve their recruitment and retention rate of Foster Carers?
  - Have a team member responsible for co-ordinating training aspects.
  - More training is needed for carers specific to caring for challenging behaviour, attachment, mental health issues.
  - Training is being identified by staff and carers unfortunately funding is not available.
  - Recruitment is on-going, linking with Hartlepool Mail and Hartbeat.
  - Targeted recruitment is undertaken throughout the year e.g. advertising in mail supplements, back of parking tickets etc.
  - Retention is not a problem. Very few carers leave to go to other agencies. Some carers have left independent agencies to come to us.
  - Carers need support and sometimes staffing issues affect the service we are able to offer.

Appendix A

- It is not unusual for the team to be carrying vacancies (currently two posts filled by agency staff).
- 4. Is there anything else you would like to add?
  - Staff work very hard and enjoy the work. We just don't feel valued.
  - Cannot access ICS for our forms and case notes. This adds time as we have to record on carer's files and then add notes to the child's record on ICS.
  - Aren't kept up to date on new developments in fostering.
  - The fostering task has changed significantly over the past twenty years and carers are increasingly asked to deal with very challenging children. With the best will in the world this is very difficult and placement breakdown is not necessarily a failure on the carers part.
  - To link in End of Placement Reports to the part where children are discharged from care or change placement. Would ensure receipt of evaluations as it is rare for social workers to complete them. It is essential that we get them back as the information continues to review etc and where they have been issues there is written evidence of this from the social worker.
