30. Apologies For Absence

Apologies had been received from The Mayor, Stuart Drummond, Councillors Shaun Cook and Steve Allison

31. Declarations of Interest

None.

32. Minutes of the Meeting held on 19 January 2009 and 2 February 2009

The minutes of the meetings were accepted as an accurate account with the addition of one tender to the Training and Development Framework.

33. Protocol for Tender Submissions – Head of Procurement, Property and Public Protection

The Head of Procurement, Property and Public Protection attended the meeting following concerns from the Committee that tenders were not being returned in a uniform way. He stated that there was guidance for officers available on the Intranet system but a procedure/checklist for officers to complete throughout the tender process was also given to officers. Amongst other things, this advised officers to issue an envelope/labels for prospective tenderers to return their tenders to the

Council. The checklist was circulated to Members for their information. Members asked that it could be highlighted on this checklist for officers that a 'front sheet' with the name and address of the tenderer and the price submitted should be included in the instructions. Members queried whether the Committee could refuse to open tenders which did not adhere to the guidelines issued and were informed that the instructions were part of the Council's Constitution although the front sheet was merely a request. The Senior Legal Assistant said that this could be darified. It was also highlighted by a Member that certain postal companies require senders to put a return address on the document and it should be stressed to tenderers that envelopes should not contain any contact details.

A Member asked whether there was any time/financial penalty built into contracts when awarded and was informed that this was able to be done in certain circumstances.

Decision

The verbal update was noted by Members.

34. Provision of Asbestos Surveys – Head of Procurement, Property and Public Protection

The Head of Procurement, Property and Public Protection presented the report which was given to receive and approve the proposed list of contractors for the initial provision of non-intrusive (Type 2) asbestos surveys to schools and thereafter, other public buildings. The contractors were initially required for the Building Schools for the Future (BSF) programme but in the future asbestos surveys of all types would be required to both schools and other corporate buildings. A number of specialist contractors had been identified and the budget identified for these surveys was £60,000 to be funded from the BSF programme. All the identified companies had passed Health & Safety and Financial considerations and if the list was approved, these companies would be used in future provision. Members expressed concern that asbestos should be dealt with properly and Health & Safety procedures followed and were assured that the Authority had legislation in place regarding this substance.

A Member asked how long a company (not specifically pertaining to this contract) would be excluded from applying for contracts once prohibited for any reason. The Head of Procurement, Property and Public Protection stated that it depended on the severity of the problem, but should this happen, the Committee would be consulted.

35. Tender Exercise for the Provision of Care Support and Navigation Services to Improve Stroke Services – Strategic Commissioner – Older People

The Principal Commissioning Manager reminded Members that one tender had been received within the required timescales and had been opened at the Contract Scrutiny Committee on 19 January 2009. This was in response to the Department of Health National Stroke Strategy to provide support for stroke sufferers. Grant money had been made available to provide advice, information, support and access to practical advice, participation in community life as well as options to return to work. The tender had been subjected to rigorous evaluation regarding its organisational profile, technical capacity, financial capability and Health and Safety aspects. References had been given from Middlesbrough, Redcar & Cleveland and Darlington Primary care Trusts. A further detailed evaluation had also been made by officers and the Chairs of Hartlepool Stroke Club and Young Stroke Clubs. The National Stroke Association had scored 91% in its evaluation and therefore the Director of Adult and Community Services was happy to offer the contract to that organisation.

Decision

The committee noted the high scoring achieved by the National Stroke Association and the awarding of the contract to that organisation.

Subject: RESULTS OF TENDER FOR PROVISION OF

TRAINING & DEVELOPMENT

1. PURPOSE OF REPORT

1.1 To inform members of the committee of the decision made regarding appointing contractors to the framework agreement for the provision of training & development to the Council.

2. BACKGROUND

- 2.1 This contract is to establish a framework agreement for the provision of training & development across the authority. In certain circumstances the Council reserves the right to use someone NOT on the framework agreement to provide training and development support. For example:-
 - if a specified provider is linked to a particular funding stream;
 - where a new need has been established which an existing provider could not address;
 - where product training is provided as part of another contract;
 - where this is a requirement in relation to regional or national partnership delivery mechanisms or;
 - as determined by the contract officer, e.g. in relation to social care, where the need arises resulting from changes in national policy, guidance or safeguarding issues.
- 2.2 Where the framework agreement is to be used it provides a list of approved providers who can be used as part of a mini-competition for work in this area. The in-house providers (e.g. Adult Education) will always be considered in the first instance. The need for the new agreement was reported to and agreed by the Performance Portfolio Holder on 25th July 2008.
- 2.3 This agreement is to provide training & development, under a number of different headings and areas for four years, expiring on 31 March 2013. The services required will be funded by the individual departments who require training and development and it will be the department who

identifies the need, who will write the specification, and will evaluate the responses to the mini-tendering exercise with support from the corporate Workforce Development Team.

- 2.4 The rationale for the introduction of the framework is to:-
 - Ensure that services are commissioned correctly, ensuring best value is obtained every time;
 - Coordinate the transactions taking place between the authority and suppliers to reduce duplication and ensure the correct financial procedures are followed;
 - Undertake consistent and objective assessment of providers against a set of agreed performance standards to ensure that delivery is of the highest quality every time.
- 2.5 The tender was advertised in the Evening Gazette, Hartlepool Mail, OJEU website and the Council's and Supply 2 websites. In addition to this, all current suppliers were written to and informed of our plans to change the way to "buy-in" their services. Suppliers were also invited to attend a consultation event to discuss the proposals before the formal tender process was undertaken and this then helped to shape the information and timescales used. Two members of staff, who have worked on this project, also attended a meet the buyer event at the Historic Quay.
- 2.6 All received tenders were opened at the meeting of the Contract Scrutiny Committee on 2nd February 2009. A total of sixty-two companies submitted proposals for undertaking the service and these are listed in Appendix 1, those highlighted in red show the organisations that were unsuccessful.

Appendix 1 contains exempt information under Schedule 12A of the Local Government Act 1972, (as amended by the Local Government (Access to Information)(Variation) Order 2006) namely, 3. Information relating to the financial or business affairs of any particular person (including the authority holding that information).

3. ASSESSMENT OF TENDERS

- 3.1 The process to date has had two stages to the evaluation. A prequalification questionnaire (PQQ) was used in the first instance. 121 PQQ's were received and 87 organisations were invited to tender. Of those 87 invitations, 62 tenders were received, each being able to offer different expertise across a matrix of over 90 "lots." "Lots," in this instance, were the different categories of training and development needed by the organisation. A copy of the "lots" is attached as Appendix 2.
- 3.2 During the course of undertaking the evaluations it became evident, partly as a consequence of some recent high profile social care issues elsewhere in the country and the need to avoid similar issues within Hartlepool, that further initial evaluation is needed in respect of the specialist social care

- "lots" namely. Those "lots" affected are indicated in Appendix 2. It was identified that organisations on the list may not fulfil certain specialist requirements and an additional evaluation for these areas is required. The additional evaluation will include having detailed discussions with potential providers and establishing the ability of the organisations to deliver training to the Council's satisfaction in respect of matters listed in Appendix 3.
- 3.3 It is envisaged that the results of the additional evaluation will be completed by 30 September 2009, be reported to a Contract Scrutiny Committee meeting in October 2009 and be incorporated into the framework agreement thereafter. In order to ensure consistency of renewal date for the framework agreement, the same end date of 31 March 2013 will apply. After further evaluation, the following will be identified:
 - a) the training to be delivered within the framework agreement;
 - b) the training which is to be delivered outside of the framework agreement as it falls into one of the examples detailed in 2.1 above or where there are no providers within the framework agreement able to deliver the training needed.
- 3.4 Whilst the additional evaluation is being undertaken, existing arrangements for procuring specialist social care training will continue. The additional evaluation will delay the full financial benefits of the framework agreement being achieved, however it is considered that the risks of providing inappropriate training outweigh this.
- 3.5 In respect of the non specialist social care "lots", a decision was made on the basis of price (30%) and quality (70%) of the submissions received and those with an overall score, who met the minimum standard, have been successful to become part of the framework agreement.
- 3.6 As a result of the evaluation process for non specialist social care lots, the decision has been made to award contracts within the framework agreement to those organisations indicated in column 4 of Appendix 1 who met the minimum standard with many exceeding the standard.
- 3.7 Where organisations have tendered for both specialist social care and non-specialist social care "lots", the award of contract and indusion in the framework agreement from 1 April 2009 will be limited to the non-specialist social care "lots" only. It is feasible that an organisation could be included in the framework agreement for non-specialist social care "lots" but not the specialist social care "lots" as the evaluation criteria will be different. The award of the contract (and inclusion on the framework agreement) does not guarantee work to any supplier, only the opportunity to be part of a mini-competition within the "lots" for which they tendered and have been contracted for.

4. RECOMMENDATION

- 4.1 That members of the panel note:
 - a) the award of the framework agreement in respect of the non-specialist social care "lots";
 - b) the additional arrangements in respect of the specialist social care "lots".
