40. Chief Executive's Departmental Plan 2008/09 – 3<sup>rd</sup> Quarter Monitoring Report (Chief Financial Officer, Chief Solicitor and Director of Neighbourhood Services)

### Type of decision

Non-key.

#### **Purpose of report**

To inform the Portfolio Holder of the progress made against the Chief Executive's Departmental Plan 2008/09 in the first three quarters of the year.

#### Issue(s) for consideration by Portfolio Holder

The report provided an overview of the third quarter across the Finance, Legal and Procurement Divisions. It included the key actions that were included within the Plan with an update on progress against every action and where appropriate against relevant performance indicators. A short summary which explained progress made to date, identifying the expected outcome of each action set out within the plan was also included using the Covalent system.

The Chief Financial Officer highlighted that the areas identified as being delayed within the financial section were expected to be back on target and completed within this financial year. The Portfolio Holder was asked to note that additional staff were being recruited to deal with the speed of processing changes in circumstances. This recruitment was being funded from a number

of vacant posts already within the Division and would ensure that the Council remained in the top quartile for the speed of response to new claims and changes in circumstances where it affected entitlement.

The Portfolio Holder expressed concern at the length of time it was taking to process job evaluation appeals and suggested a report be submitted to Cabinet to provide an update on progress.

- (i) The achievements of key actions were noted and the changes in completion dates indicated within the report were approved.
- (ii) That a report be submitted to a future Cabinet meeting outlining progress made to date in the job evaluation appeal process.

# **41. 5 Year Procurement Plan** (Head of Procurement, Property and Public Protection)

### **Purpose of report**

#### Issue(s) for consideration by Portfolio Holder

The Plan acts as a strategic tool to bring together the significant procurement activity of the Council linking with elements of the Council's strategic framework. It was noted that since the last update, the Council's register of contacts had been developed and Departments had been active in this process. However, there was some work to do in analysing spend and putting appropriate contracts in place.

The Portfolio Holder indicated that as Procurement Champion he would like to be involved more and suggested that a meeting be arranged with relevant officers to discuss the Council's procurement process including work on Schools Transformation procurements.
