Procedure for Hearings

- 5. Questions by Members to applicant and/or applicant's witnesses.
- 6. Representations by responsible bodies and/or interested parties and witnesses introduced where appropriate.
- 7. Questions by Members to responsible bodies/interested parties and/or their witnesses.
- 8. Parties may question and clarify issues raised with the consent of the Chair.
- 9. If required, responsible bodies/interested parties be given opportunity to sum up.
- 10. If required, the applicant to be given opportunity to sum up.
- 11. Members to have the opportunity to clarify any points raised. The Chair shall ask whether all parties are satisfied they have said all they wish to.

Subject: APPLICATION FOR THE VARIATION OF A GAMING MACHINE PERMIT – YATES, VICTORIA ROAD

1. PURPOSE OF REPORT

1.1 To consider an application for the variation of a gaming machine permit in respect of Yates, Victoria Road, Hartlepool.

2. SUMMARY OF APPLICATION

- 2.1 Applicant: Town & City Pub Company Premises: Yates Victoria Road Hartlepool
- 2.2 The application is for the variation of a current gaming machine permit so as to increase the number of Category C gaming machines from three to four.
- 2.3 On 14th March 2007 Members of the Licensing Committee determined that applications for four or more gaming machines must be referred to a Licensing Sub-Committee for consideration.

3. BACKGROUND

3.1 A gaming machine is defined in the Gambling Act 2005 as: -

'A machine which is designed for use by individuals to gamble (whether or not it can be used for other purposes'.

3.2 A Category C gaming machine is limited to a maximum stake of 50p and a maximum prize of £35. A Category D gaming machine is limited to a maximum stake of 10p (30p in tokens) and a maximum prize of £5 (£8 in tokens).

- 3.3 Category C gaming machines may only be used by players whose minimum age is 18. There are no age restrictions for Category D machines.
- 3.4 The Gambling Act 2005 states that there are no restrictions on the number of Category C and D machines that an alcohol licensed premises may have but that any more than two machines must be determined by the local licensing authority.
- 3.5 The applicant premises has a valid alcohol licence issued under the Licensing Act 2003.

4. ISSUES

- 4.1 Schedule 13 of the Gambling Act 2005 states that, when considering permit applications, licensing authorities shall have regard to the Act's licensing objectives and any guidance issued by the Gambling Commission and any other matters it thinks relevant.
- 4.2 The licensing objectives are: -
 - Preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime;
 - b) Ensuring that gambling is conducted in a fair and open way; and
 - c) Protecting children and other vulnerable persons from being harmed or exploited by gambling
- 4.3 The Council's Gambling Act Policy states that, in relation to applications for permits: -

Matters will be decided on a case by case basis but generally there will be regard to the need to protect children and vulnerable persons from harm or being exploited by gambling. The applicant will be expected to satisfy the authority that there will be sufficient measures to ensure that under 18 year olds do not have access to the adult only gaming machines.

Measures which will satisfy the authority that there will be no access may include whether adult machines are in sight of the bar, or in sight of staff who will monitor that the machines are not being used by those under 18. Notices and signage may also help. As regards the protection of vulnerable persons applicants may wish to consider the provision of information leaflets/helpline numbers for organisations such as GamCare.

- 4.4 Holders of gaming machine permits must comply with any Code of Practice issued by the Gambling Commission about the location and operation of the machine. A copy of this code of practice is attached as **Appendix I**.
- 4.5 On considering an application for a permit a licensing authority shall: -
 - 1) Grant the application
 - 2) Refuse the application; or
 - 3) Grant it in respect of: -
 - (i) a smaller number of machines that than specified in the application,
 - (ii) a different category of machines from that specified in the application, or
 - (iii) both.
- 4.6 Members may not attach conditions to a permit.

5. **RECOMMENDATIONS**

5.1 That Members consider whether the application should be granted.

Appendix 1 GAMBLING COMMISSION

Gaming Machine Permits Code of Practice

- Club Gaming Permits and Club Machine Permits

- Alcohol Licensed Premises Permits and Permissions

June 2007

Introduction

- i. This is the Gambling Commission's Code of Practice issued under section 24 Gambling Act 2005 (the Act) relating to provision of facilities for gambling in accordance with club gaming, club machine and licensed premises gaming machine permits. This includes:
 - registrations under Parts II and III Gaming Act 1968 which, under transitional provisions, are treated as club gaming and club machine permits respectively; and
 - alcohol licensed premises gaming machine permits (formerly s34 1968 Act permits).
- ii. The Code will come into force on 1 September 2007.
- iii. Those items marked in bold and shaded are the provisions which are a condition of the permit and must be complied with.

Section A: Location and operation of machines

All permit holders

Compliance with these provisions is a condition of your permit, and failure to do so could result in revocation of the permit.¹

1 All gaming machines situated on the premises must be located in a place within the premises so that their use can be supervised, either by staff whose duties include such supervision (including bar or floor staff) or by other means.

Permit holders must have in place arrangements for such supervision.

2 All gaming machines situated on the premises shall be located in a place that requires a customer who wishes to use any ATM made available on the premises to cease gambling at the gaming machine in order to do so. 'ATM' means a machine located on the premises, which enables a person using it to obtain cash by use of a credit or debit card.

¹ Compliance with these provisions is a condition of the relevant permit as a result of the Gambling Act 2005: section 271 for Club Gaming Permits, section 273 for Club Machine Permits, section 282 for alcohol licensed premises using their automatic machine permissions and section 283 for licensed premises Gaming Machine Permits and alcohol licensed premises Gaming Machine Permits.

Section B: Access to gambling by children and young persons

All permit holders

This section sets out the best practice which the Gambling Commission considers should be implemented by permit-holders, compliance with this provision is <u>not</u> a condition of your permit.

- 3 Permit holders should put into effect procedures intended to prevent underage gambling. This should include procedures for:
 - checking the age of apparently underage customers; and
 - refusing access to anyone who appears to be underage, and who tries to use category B or C gaming machines and cannot produce an acceptable form of identification.
- 4 Permit holders should take all reasonable steps to ensure that all relevant employees understand their responsibilities for preventing underage gambling.
- 5 Permit holders should only accept identification which:
 - contains a photograph from which the individual can be identified;
 - is valid; and
 - is legible and has no visible signs of tampering or reproduction.

(The Commission considers acceptable forms of identification to include any identification carrying the PASS logo (eg Citizencard, Validate and the Government's own Connexions card); driving licence (including a provisional licence) with photocard; and passport).

6 Procedures should be in place for dealing with cases where a child or young person repeatedly attempts to gamble on category B or C machines, including oral warnings, reporting the offence to the Gambling Commission and the police, and making available information on problem gambling.

Section C: Self exclusion

This section sets out the best practice which the Gambling Commission considers should be implemented by permit-holders, compliance with this provision is <u>not</u> a condition of your permit.

Club gaming permit and club machine permit holders only

- 7 Permit holders should put in place procedures for self-exclusion and take all reasonable steps to refuse service or to otherwise prevent an individual who has entered a self-exclusion agreement from participating in gambling.
- 8 Permit holders should implement procedures designed to ensure that an individual who has self-excluded cannot gain access to gambling; this includes:
 - a register of those excluded with appropriate records (name, address, other details, and any membership or account details that may be held by the operator);
 - photo identification (where available and in particular where enforcement of the system may depend on photographic ID), and a signature;
 - staff training to ensure that relevant staff are able to enforce the systems; and
 - the removal of those self-excluded persons found in the gambling area or attempting to gamble from the premises.

Gaming Machine Permits Code of Practice: Issued June 2007

- 9 Self-exclusion procedures should require individuals to take positive action in order to selfexclude. This can be a signature on a self-exclusion form.
- **10** Before an individual self-excludes, permit holders should provide or make available sufficient information about what the consequences of self-exclusion are. Customers should be given the opportunity to discuss self-exclusion in private, where possible.
- 11 Permit holders should take all reasonable steps to ensure that:
 - the self-exclusion period is a minimum of six months and give customers the option of extending this to a total of at least five years;
 - a customer who has decided to enter a self-exclusion agreement is given the
 opportunity to so do immediately without any cooling off period. However, if the
 customer wishes to consider the self exclusion further (for example to discuss
 with problem gambling groups) the customer may return at a later date to enter
 into self exclusion;
 - at the end of the period chosen by the customer (and at least six months later), maintain the self-exclusion in place, unless the customer takes positive action in order to gamble again. No marketing material may be sent to the individual unless that has taken positive action in order to gamble again, and has agreed to accept such material; and
 - where a customer chooses not to renew, and makes a positive request to begin gambling again, give the customer 1 day to cool off before being allowed access to the gambling facilities.
- 12 Please note that the Commission does not require the permit-holder to carry out an assessment or make any judgement of whether the individual should have access to gambling. The requirement to take positive action in person or over the phone is purely to:
 - a) check that the customer has considered the decision to access gambling again and allow them to consider the implications; and
 - b) implement the 1 day cooling-off period and explain why this has been put in place.

1. PURPOSE OF REPORT

1.1 To consider an application for the variation of a premises licence in respect of 22-23 Church Street, Hartlepool.

2. BACKGROUND

- 2.1 Applicant: Miss Danielle Maria Massey Premises: 22-23 Church Street Hartlepool
- 2.2 The current licence authorises the following activities: -

2.3 A copy of the current premises licence is attached as **Appendix I.**

3. SUMMARY OF APPLICATION

- 3.1 The applicant has applied for a number of additional activities to be added to the licence and for all activities to be available until 4:00 a.m. 7 days a week.
- 3.2 The proposed new activities and licensed hours are detailed as follows: -

- 3.3 The application has also stated that adult entertainment may be provided.
- 3.4 The proposed closing time for the premises is 4:30 a.m. hours 7 days a week.
- 3.5 A copy of the application is attached as **Appendix II**.
- 3.6 The application has been advertised in the prescribed manner and two relevant representations have been received from Planning (Appendix III) and Cleveland Police (Appendix IV).
- 3.7 The representation from Planning states that there is currently only planning permission in place for the ground floor of the premises whereas the proposed application refers to the current licensed area of both the ground floor and first floor.
- 3.8 The representation from Cleveland Police states that an extension to the opening hours for the premises would undermine the crime and disorder licensing objective and questions the ability of the current Designated Premises Supervisor to manage the extended hours.

4. ISSUES

- 4.1 As relevant representations have been received within the prescribed time, a hearing must be held for Members to consider those representations (unless all parties agree a hearing is unnecessary).
- 4.2 The licensing objectives are:
 - a) the prevention of crime and disorder;
 - b) public safety;
 - c) the prevention of public nuisance; and
 - d) the protection of children from harm
- 4.3 The Planning Department has indicated that there is no appropriate planning permission for the first floor of the premises and therefore any

variation of the current licence would be a breach of current planning permission.

- 4.4 Hartlepool Borough Council's Licensing Policy states that premises 'must have suitable, appropriate authorised use under planning legislation' and that 'The Licensing Authority will not normally entertain an application for a licence unless the applicant can demonstrate that the premises have an appropriate planning consent.'
- 4.5 Should Members determine that the application should be granted, it would be possible to add a condition to the licence stating that it would only take effect in relation to the first floor when appropriate planning permission had been obtained. This would prevent the applicant from having to make a further licence application once planning permission was in place.
- 4.6 Cleveland Police have stated that the area in which the premises are situated already suffers significantly from alcohol related crime and disorder, especially after 2:00 a.m. and that, in their opinion, granting the application would undermine the crime and disorder licensing objective.
- 4.7 Cleveland Police have also stated that they are concerned that the current Designated Premises Supervisor, Mr David Lai, has never been present at the premises when visited by the Police Licensing Officer.
- 4.8 Having regard to the representations received, Members may take any of the following steps for the promotion of the licensing objectives.
 - 1) Grant the application without amendment
 - 2) Grant the application with conditions, or amended conditions
 - 3) Reject those parts of the variation that are relevant to the representations received
- 4.9 Members are reminded that they must only consider those aspects of the licence variation that are relevant to the representations received.

5. **RECOMMENDATIONS**

5.1 That Members consider the representations made by the applicant and responsible authorities and determine what aspects, if any, of the proposed variation should be granted and, if appropriate, what conditions if any, should be attached.

ANNEX 1 – Mandatory Conditions

- 1 No supply of alcohol may be made under the premises licence
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises superviser does not hold a personal licence or his personal licence is suspended

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

- 1 Except with the prior written approval of the Licensing Authority and subject to any conditions which may be attached to such approval:-
 - (a) No special effects, naked flames, smoke production or any process creating a risk of fire, or the illusion of smoke or fire shall be used for the purpose of providing regulated entertainment on the premises.
 - (b) No explosives or highly flammable substances shall be brought into or used on the premises
 - (c) No special effects shall be used or displays given on the premises, which consist of or include the use of lasers

Applications for consent, giving detailed descriptions of the equipment to be used and details of the event, including dates and times must be made not less than 28 days before the date of the event.


- 2 There shall be maintained on the premises at all times an adequate and appropriate supply of first aid equipment and materials for use by patrons.
- 3 The licensee must ensure that the electrical socket outlets in the licensed premises, which are used for the purpose of providing licensed entertainment are protected by a residual current device being a 30 MA tripping circuit.
- 4 In the event of the fire alarm being activated a suitable relay must be provided so that the electrical power supply to all sound amplification system in the licensed premises must be immediately intercepted so that the alarm ca be clearly heard in all parts of the licensed premises.
- 5 A drugs policy shall be implemented and monitored by staff during operating hours.
- 6 CCTV shall be installed, in operation and monitored by staff during operating hours.
- 7 Signage shall be displayed in prominent positions near exits requesting customers to leave in a quiet and orderly manner.
- 8 During the provision of live or recorded music all reasonable steps will be taken to avoid disturbance to neighbouring properties.
- 9 Persons under 18 years of age are prohibited unless they are accompanied by an adult.
- 10 Signage shall be displayed in prominent positions, at all bars, stating that supply of alcohol to children is prohibited and illegal.



Cleveland Police wish to make representations to the above application to vary the hours of opening until 4.30am for the following reasons:

Historically, an increase in hours has lead to an increase in alcohol related crime and disorder. The area in which the premises is situated already suffers significantly from alcohol related crime and disorder, especially after 2.00am – the time in which the premise currently close. Cleveland Police are therefore of the opinion that if this application is granted, the likely effect will be that the crime and disorder objective will be undermined.

In addition to the above, Cleveland Police are concerned that the current DPS, Mr Lai has never been present at the premises when PC Swales, Licensing Officer has attended. It is understood that Mr Lai's business interests are in the Newcastle area. Cleveland Police believe that Danielle Massey will eventually take over the role of DPS after having successfully completed a personal licence course and applied for her personal licence. Therefore, Ms Massey is inexperienced.
