- 6. Representations by responsible bodies and/or interested parties and witnesses introduced where appropriate.
- 7. Questions by Members to responsible bodies/interested parties and/or their witnesses.
- 8. Parties may question and clarify issues raised with the consent of the Chair.
- 9. If required, responsible bodies/interested parties to be given opportunity to sum up.
- 10. If required, the applicant to be given opportunity to sum up.
- 11. Members to have the opportunity to clarify any points raised. The Chair shall ask whether all parties are satisfied they have said all they wish to.

Subject: APPLICATION FOR THE VARIATION OF A PREMISES LICENCE FOR OLIVITOS TAKE-AWAY RESTAURANT

## 1. PURPOSE OF REPORT

1.1 To consider an application for the variation of a Premises Licence in respect of Olivitos, York Road, Hartlepool.

## 2. BACKGROUND

2.1	Applicant:	Jamal Shirvani

- 2.2 This application is for the variation of a Premises Licence that was issued in respect of these premises on 19<sup>th</sup> September 2005.
- 2.3 The current licence authorises the following activities: -

Late Night Refreshment	Sunday – Wednesday	2300 – 0100
	Thursday – Saturday	2300 – 0300

- 2.4 The current licence contains the following conditions: -
  - On Thursday, Friday and Saturday nights between midnight and until the premises are closed, an S.I.A. licensed Door Supervisor shall be on the premises.
  - The premises shall close to the public no later than 15 minutes after the last sale.
  - A CCTV system shall be installed and maintained and shall operate during licensed hours.

## 3. SUMMARY OF APPLICATION

3.1 The applicant has applied for the variation of the Premises Licence in the following terms: -

Late Night Refreshment Mon – Sun 2300 – 0300

- 3.2 A copy of the application is attached as Appendix I.
- 3.3 The application has been advertised in the prescribed manner and one representation has been received **from Hartlepool Borough Council's Planning Department** (Appendix II).
- 3.4 The representation from the Planning Department highlights that the premises are not situated within the area that the Hartlepool Local Plan has designated for late night use and that there is the potential for a cumulative impact on disorder and public nuisance.

## 4. ISSUES

- 4.1 As relevant representations have been received within the prescribed time period, a hearing must be held for Members to consider those representations (unless all parties agree a hearing is unnecessary).
- 4.2 Members are also advised that the applicant's premises are situated within Hartlepool's 'Special Policy' area.
- 4.3 As the Licensing Act 2003 defines late night refreshment as the provision of hot food after 11:00 p.m. Members may not impose any conditions, or hours restrictions that would have effect prior to this time.
- 4.4 No complaints have been received by the Public Protection and Housing Division regarding noise emanating from the premises.
- 4.5 The licensing objectives are:
  - a) the prevention of crime and disorder;
  - b) public safety;
  - c) the prevention of public nuisance; and
  - d) the protection of children from harm
- 4.6 Having regard to the representations received, Members may take any of the following steps for the promotion of the licensing objectives.
  - 1) Grant the application without amendment
  - 2) Grant the application with conditions, or amended conditions
  - 3) Reject the application in full, or in part
- 4.7 Members are reminded that they must only consider those aspects of the licence application that are relevant to the representations received.

#### 5. **RECOMMENDATIONS**

5.1 That Members consider the representations made by the applicant and interested parties and determine whether the licence variation should be granted and, if appropriate, what conditions, if any, should be attached.



We would make representations/comments on the following licensing application:

#### 1. Olivitos, 94 York Road

'Olivitos' is a two-storey property situated on the eastern side of York Road. The site lies outside the defined late night zone for uses opening later than midnight. There is a proliferation of licensed premises in this area. Residential properties are located behind the frontages of commercial properties on the western side of York Road.

Our records indicate the premises do not have any opening hours planning restrictions. Our concerns are that the premises is not in the defined late zone as defined in Policy Rec 13 of the emerging Hartlepool Local Plan 2005 and the proposed later opening hours may have a potential to have a cumulative impact on disorder and public nuisance in this part of York Road.
