# 28. Information from a representative of the Energy Saving Trust Advice Centre

Colin MacDonald from the Energy Saving Trust Advice Centre addressed members. He highlighted the partnership work which had taken place with Hartlepool Borough Council over previous years and thanked members for embarking upon the investigation into climate change and carbon management. The Energy Saving Trust would continue to work closely with HBC on the delivery of an action plan. The Chair thanked Mr MacDonald for his positive comments.

## 32. Scrutiny Investigation into Climate Change and Carbon Management – Evidence from a Representative from Middlesbrough Council (Scrutiny Support Officer)

In March 2008 Middlesbrough Council and Partner Organisations were awarded Beacon Status for tackling Climate Change, one of six council across England to be given this award. The Beacon Award Scheme is run by the Improvement and Development Agency (IDEA) and recognises councils that demonstrate clear leadership, excellent vision and innovation on key themes

Bob King, Middlesbrough Borough Council's Sustainability Co-ordinator, had therefore been invited to provide evidence in relation to the ongoing investigation into 'Climate Change and Carbon Management'. Mr King played

a DVD and gave a PowerPoint presentation, both of which had been used by Middlesbrough Council during their successful application for Beacon status. Mr King highlighted a number of aspects, specifically Middlesbrough's signing up to the Nottingham Declaration on Climate Change, their carbon reduction targets and key achievements so far. The One Planet Living programme was also outlined.

A member praised Middlesbrough officers for their efforts however felt that if only 60% of the planet were acting, only so much could be achieved if the other 40% continued polluting. Mr King acknowledged this but said that those countries which polluted the most were those which were making the biggest strides in this area. Comment was often made about China's energy usage but as a country they were far more proactive than most in understanding sustainable technology and energy. African countries tended to use far less resources than the UK and USA and it seemed only fair that those countries polluting the most should contribute the most to putting it right.

A member queried how much Council funding Environment City had been given. Mr King confirmed that £110,000 had been given by Middlesbrough Council with the rest coming from charitable funding which the Council did not have access to.

The Chair asked Mr King for more information in successful areas of engagement. Mr King indicated that integrating climate change priorities with other priorities such as fuel poverty tended to increase public interest. He highlighted in particular an initiative whereby drivers were encouraged to use their cycles around the town centre through the provision of a free central storage facility. The Chair requested that further information on the cycling Mr King felt that initiative be circulated to the Forum for information. partnership working was at the root of their success in this area. Middlesbrough had also employed the first full-time climate change officer in the UK and now had a second officer working on the adaptation strategy on a temporary contract. In terms of planning policy this could be problematic because while planners had to work within government guidelines they were perfectly able to build elsewhere if they felt the requirements imposed by Middlesbrough Council were too steep. Therefore there needed to be some negotiation in these matters. However a number of new builds in Middlesbrough, specifically the Middlehaven development, were being constructed to high sustainability standards and it was hoped that others could be encouraged to build to these high standards. The Chair requested that further information on Middlesbrough Council's planning policies and sustainability standards be circulated to the Forum.

A Resident commented that the presentations had concentrated on future initiatives at the expense of the here and now, with little information on composting and recycling. Mr King reported that there was a town wide green waste collection service and home composting was encouraged. Work was underway to increase recycling rates and minimise residual waste to landfill sites outside Middlesbrough, something which would be strengthened under the One Planet Living approach. A member referred to the One Planet Living

approach, querying how many of the 10 principles were achievable in reality. Mr King acknowledged some of the targets (zero carbon, zero waste) would take a long time and could not be done without commitment from governments however challenging targets were necessary to encourage progress.

Mr King was thanked for attending the meeting and answering questions.

## Decision

That the content of the presentation be noted and used to inform members during this investigation.

That further information on Middlesbrough Council's cycling initiative, planning policies and sustainability standards be circulated to the Forum.

## 33. Scrutiny Investigation into Climate Change and Carbon Management – Evidence from the Council's Regeneration and Neighbourhoods Department (Scrutiny Support Officer)

The Environmental Standards Manager and Highway Services Manager were in attendance to provide evidence in relation to the ongoing investigation into 'Climate Change and Carbon Management'. The Environmental Standards Manager outlined examples of the work that had been completed, or was underway, to reduce the carbon footprint of Hartlepool Borough Council. A number of potential projects were also introduced to contribute to the Carbon Management Programme and associated strategies. The ultimate aim was to reduce the Council's carbon emissions by 35% within five years. Details were given of current initiatives and a list of future projects was appended to the report.

The Highway Services Manager detailed the environmental impact of street lighting and the benefits of the new energy efficient technology. Examples were given of recent initiatives in this area.

A resident referred to plans to switch street lighting on later and off earlier, querying if a safety analysis had been carried out. The Highway Services Manager advised that the lighting worked on the basis of natural light levels. A trial had been carried out on Headland Square where there were very few light sources and this had so far been successful. Further monitoring would be carried out but nothing permanent would be done unless it was safe. A member queried whether there was a legal requirement for roads to be lit to a certain standard. The Highway Services Manager indicated there was and that plans to roll out white light technology were on hold until these standards could be met. Reference was made to the A179, the Chair asked that lighting on this road be checked outside of the meeting. Reference was also made to disposal of fluorescent tube lights.

The Chair thanked the Environmental Standards Manager and Highway Services Manager for attending the meeting and answering questions.

## Decision

That the content of the presentations be noted and used to inform members during this investigation.

## 34. Scrutiny Investigation into Climate Change and **Carbon Management – Evidence from the Mayor as** Portfolio Holder for Community Safety and Housing and the Chair of Hartlepool's Environmental

**Partnership** (Scrutiny Support Officer)

The Mayor as Portfolio Holder for Community Safety and Housing and the Chair of Hartlepool's Environment Partnership, Councillor Peter Jackson, had submitted written evidence in relation to the Forum's ongoing investigation into 'Climate Change and Carbon Management'. The Mayor gave information on HBC's management of its carbon emissions, their plans to meet the challenges of Climate Change and Carbon Management and specific initiatives aimed at reducing energy used by the Council. Councillor Jackson detailed the roles and responsibilities of the Environment Partnership in tackling the issues of climate change and carbon emissions and suggested ways to help raise awareness of climate change in the community. Terms of reference for the Climate Change Working Group were currently being redrafted and would be circulated to the Forum when complete.

## Decision

That the written evidence be noted and used to inform members during this investigation.

## Scrutiny Investigation into Climate Change and 35. **Carbon Management – Forum Participation in a Climate Change Activity Session in conjunction with**

**11 Million Day** (Scrutiny Support Officer)

Members were advised that the yearly Environment Roundabout was an event that over 200 school children in Hartlepool participate in which aims to teach children about different aspects of the environment. Although the Roundabout was due to be held in January 2010, (which Members of the Forum would also be invited to attend) provisional arrangements had been put in place for schoolchildren and young people to come into the civic centre on 11 Million Day (6<sup>th</sup> November 2009) to take part in a range of activities. Therefore, by holding the Climate Change Activity Session on 11 Million Day would enable school children to be involved in the scrutiny process. A number of proposals

for this activity session were outlined within the report and Members expressed their support for the following proposals:-

- (a) That the session be held on the afternoon of 11 Million Day which is the 6<sup>th</sup> November 2009 in the Civic Suite;
- (b) That two activities be organised similar to the scenarios used for the Environment Roundabout;
- (c) That Members of the Forum along with a class of year 5 pupils participate in the activities, with 15 children taking part in each activity;
- (d) That each activity runs for a maximum of 20 minutes and that both groups of children and the Members in attendance come together after the activities to discuss / debate the issues covered;
- (e) In order for the children to further engage in the Scrutiny process, it is suggested that the option of the children coming along to a future meeting of the Forum to feed back their comments be explored; and
- (f) That lunch be provided before the event and the cost of this be divided between Scrutiny, the Children and Families section and the Environmental Standards section; and that a request for funding from the Dedicated Scrutiny Budget for this lunch be submitted to Scrutiny Co-ordinating Committee for approval.

The Chair encouraged member participation in the activity session.

## Decision

That the climate change activity session be held in conjunction with 11 Million Day and that a letter of invitation be sent to Members.

## 1. PURPOSE OF REPORT

1.1 To provide the opportunity, as part of the Budget and Policy Framework initial consultation proposals for 2010/2011, for the Neighbourhood Services Scrutiny Forum to consider the Regeneration and Neighbourhoods Department's pressures and priorities relating to the provision of neighbourhood services.

## 2. BACKGROUND INFORMATION

- 2.1 At a meeting of the Scrutiny Co-ordinating Committee held on 16<sup>th</sup> October, 2009, consideration was given to the Executive's Initial Budget and Policy Framework consultation proposals for 2010/2011 to 2012/2013.
- 2.2 At this meeting it was agreed that, as in previous years, each of the Standing Scrutiny Forums will consider the budget proposals covering the service areas within their remit. Given the recent restructure of departments within the Council, and creation of the Regeneration and Neighbourhoods Department and Child and Adult Department, presentations will also be given by Directors to provide an overarching view of the general risks facing their departmental budgets and key policy issues for this year. Any comments / observations will then be fed back to the meeting of the Scrutiny Co-ordinating Committee to be held on 27<sup>th</sup> November, 2009 to enable a formal response to be presented to Cabinet on 14<sup>th</sup> December, 2009.

- 2.4 Cabinet is proposing that the pressures identified are funded. In relation to the priorities Cabinet is not proposing that these items are funded.
- 2.5 At this stage of the budget process Cabinet have not identified specific efficiency proposals for individual departments as it is envisaged the savings necessary to balance the 2010/2011 budget will be achieved from the Business Transformation Programme. This position assumes pressures will not exceed the available budget head room and the Government confirm the grant increase for 2010/2011.
- 2.6 To assist Members of this Scrutiny Forum in the consideration of the initial proposals, arrangements have been made for the Director of Regeneration and Neighbourhood Services to be in attendance and an invitation to this meeting has also been extended to the relevant Portfolio Holder(s) (attendance subject to availability).
