## 1. PURPOSE OF REPORT

1.1 To consider an application for the variation of a premises licence in respect of 77 Church Street, Hartlepool.

## 2. BACKGROUND

2.1 Applicant: Mr Mohammed Jamal Hajaj

Premises: 77 Church Street Hartlepool

2.2 The current licence authorises the following activity: -

Late Night Refreshment Monday to Sunday 23:00 – 03:00

2.3 Acopyof the current premises licence is attached as **Appendix I.** 

#### 3. SUMMARY OF APPLICATION

- 3.1 The applicant has applied for an extension of trading hours so as to permit the supply of late night refreshment until 04:30 hours 7 days a week.
- 3.2 Acopyof the application is attached as **Appendix II**.
- 3.3 The application has been advertised in the prescribed manner and one relevant representation has been received from **Cleveland Police** (Appendix III).
- 3.4 The representation from Cleveland Police states that any extension to the current opening hours would increase problems associated with late night revellers in the vicinity and would therefore undermine the 'crime and disorder' and 'public safety' licensing objectives.

## 4. ISSUES

- 4.1 As a relevant representation has been received within the prescribed time, a hearing must be held for Members to consider those representations (unless all parties agree a hearing is unnecessary).
- 4.2 The licensing objectives are:
  - a) the prevention of crime and disorder;
  - b) public safety;
  - c) the prevention of public nuisance; and
  - d) the protection of children from harm
- 4.3 Cleveland Police have stated that late night refreshment establishments in the area in which the premises are situated, historically have become a flashpoint for alcohol related crime and disorder. Previous incidents of crime and disorder in the area have resulted in persons being injured which consequently placed additional demands on the Police resources. In their opinion granting an extension of the current permitted hours would undemine the crime and disorder and public safety licensing objectives.
- 4.4 Having regard to the representation received, Members may take any of the following steps for the promotion of the licensing objectives.
  - 1) Grant the application without amendment
  - 2) Grant the application with conditions, or amended conditions
  - 3) Reject those parts of the variation that are relevant to the representations received
- 4.5 Members are reminded that they must only consider those aspects of the licence variation that are relevant to the representations received.

## 5. RECOMMENDATIONS

5.1 That Members consider the representations made by the applicant and the Cleveland Police and determine what aspects, if any, of the proposed variation should be granted and, if appropriate, what conditions if any, should be attached.

Cleveland Police have received an application for a variation of the above premises licence which is a fast food take away establishment. On this basis, Cleveland Police wish to make the following representations:

The premise is situated in an area which already suffers from crime and disorder and drink related problems. Cleveland Police are concerned that if the premise is permitted to sell food until a later hour, this will result in the crime and disorder and public safety objectives being undermined.

Cleveland Police are also concerned that patrons vacating licensed public houses are fuelled with alcohol which results in late night refreshment establishments becoming a flashpoint for crime and disorder. Historically, allowing such persons to loiter unnecessarily in the vicinity has resulted in crime and disorder and persons being injured.

Mr Ian Harrison Licensing Department Hartlepool Borough Council DX 60669 Hartlepool Although each case is judged on its merits, it is not so long ago that Cleveland Police had cause to have to request that a late night refreshment shop close due to concerns regarding public safety when late night revellers attended a venue in such numbers that public safety and fear of crime and disorder were imminent unless the venue closed. There is no reason to suggest that this venue will not suffer from the same problems. This incident resulted in a drain on police resources when officers were called from other areas of the town to deal with the problem. However, if the following conditions are placed on the premises licence, Cleveland Police are of the opinion that this will assist in ensuring the licensing objectives are not undermined and if agreed, the representations made will be withdrawn:

- 1. A minimum of one SIA registered door supervisors will be employed every night from 23.00 hours until closing.
- 2. In addition to the SIA door supervisor, there will be a minimum of two members of staff on duty at all times when licensable activities take place.
- 3. The premises must have a CCTV system fitted which complies to a minimum approved standard set in partnership with Cleveland Police. The system must be maintained at regular intervals and must record whenever the premises is open for business. Recordings must be kept for a minimum of 28 days and must be made available to responsible authorities upon request.
- 4. The premises will open for licensable activities from 10.00 hours until 03.00 hours Sundays to Wednesdays, from 10.00 hours until 04.30 hours Thursdays to Saturdays and from 10.00 until 04.30 hours on every Sunday night which is followed by a Bank Holiday Monday. All customers must have vacated the premises 15 minutes after licensable activities have ceased.

In addition to the above, it is unclear how Mr Hajajj intends to promote the licensing objectives on page 19 Part P of the application. Cleveland Police request further clarification.

In the event that this application is not agreed, a witness statement from PC Swales will be sent in the near future.
