115. Apologies for Absence

Apologies for absence had been submitted on behalf of Councillors Morris and Plant.

116. Declarations of Interest

Councillor Simmons declared a personal interest in item 18 – Outcome of Building Schools for the Future (BSF) Information and Communications Technology (ICT) Invitation to Submit Final Bids (ITSFB).

117. Minutes of the meeting held on 21 December 2009

These were confirmed as an accurate account.

118. Outcome of Building Schools for the Future (BSF) Information and Communications Technology (ICT) Invitation to Submit Final Bids (ITSFB) – Head of Information Planning and Support Services

The Committee were reminded that the closing date for ITSFB documents was 6 November 2009 and that the two documents received had been opened on 9 November 2009 at the Contract Scrutiny Committee and then passed to the evaluation team. After

evaluation by the team, at the moderation meeting on 2 December 2009 it had been agreed that Northgate Education were to be selected as the preferred bidder. This had subsequently been reported to Cabinet on 14 December 2009 and the Children's Services Portfolio Holder on 5 January 2010.

Decision

The Committee noted the conclusion of the evaluation of the ITSFB and the selected preferred bidder to proceed through financial dose to contract finalisation.

Building Schools for the Future (BSF)

Design and Build Contract – Sample School

(Ref: 395)

1. PURPOSE OF REPORT

To inform the panel of the requirement to tender for the Design and Build (D&B) contract for the Building Schools for the Future Programme. This report is in relation to the Invitation to Tender (ITT).

2. BACKGROUND

- 2.1 BSF is a long term programme of investment and change in England that will help transform education for secondary age students by providing 21st century learning environments that engage and inspire young people, their teachers and the wider community.
- 2.2 Hartlepool is a Wave 5 authority in the BSF programme and has received approval from Partnerships for Schools to its Outline Business Case. This allows the authority to proceed to its D&B procurement phase of the project.
- 2.3 A significant component of the Hartlepool BSF Programme is the selection of the D&B Contractor, who initially will be engaged to undertake a major remodel of the sample school (Dyke House).
- 2.4 As part of the process, the Authority issued a PITT (Preliminary Invitation to Tender) to all six contractors of the Partnerships for Schools National Framework on 10 June 2009. Four of the contractors submitted PITT documents expressing interest in the Hartlepool BSF Programme and these submissions were opened by Contract Scrutiny Committee on 29 June 2009.

- 2.5 Evaluations of the PITT submissions took place after this date and the results of the evaluations were reported back to Contract Scrutiny Committee on 1 September 2009. The recommendation was that the members of the Committee should note that Kier and Balfour Beatty were to be taken forward to the ITT Stage.
