Subject: DOG CONTROL ORDERS: REFERRAL FROM

CENTRAL NEIGHBOURHOOD CONSULTATIVE

FORUM

1. PURPOSE OF REPORT

1.1 To inform Members of the Scrutiny Co-ordinating Committee of the recent scrutiny topic referral from the Central Neighbourhood Consultative Forum to the Overview and Scrutiny Function.

2. BACKGROUND INFORMATION

- 2.1 As outlined within the Authority's Constitution, the Scrutiny Co-ordinating Committee has the discretion to consider the appropriateness of undertaking a scrutiny investigation following a referral from the Authority's regulatory panels and other committees.
- 2.2 The Constitution dearly states that should the Scrutiny Co-ordinating Committee decide not to examine a particular 'referral', the decision must be justified and reported to Council and the referring body.
- 2.3 At the meeting of the Central Neighbourhood Consultative Forum held on 15 October 2009, a Councillor raised concerns about Dog Control Orders and how they are detrimental to responsible dog owners on particular recreation grounds.
- 2.4 After a discussion on the issue at the meeting of the Central Neighbourhood Consultative Forum held on 17 December 2009, the Forum agreed that this issue should be referred to the Scrutiny Co-ordinating Committee to determine its appropriateness of re-directing the issue for further consideration to the relevant Scrutiny Forum to explore the issue in detail.
- 2.5 Dog Control Orders fall under the remit of Neighbourhood Services therefore if the Scrutiny Co-ordinating Committee feel that it is appropriate to re-direct to the appropriate Scrutiny Forum, it is suggested that this item be considered as part of the Neighbourhood Services Scrutiny Forum's work programme for the next Municipal Year, 2010 / 11 due to its current workload commitments.

3. RECOMMENDATION

3.1 That the Scrutiny Co-ordinating Committee considers the appropriateness of undertaking a scrutiny enquiry into this matter and re-directs the issue for further consideration to the relevant Scrutiny Forum and if re-directed to the Neighbourhood Services Scrutiny Forum, the Forum considers it as part of their work programme for the 2010 / 11 Municipal Year.

Subject: 2010/11 BUDGET AND POLICY FRAMEWORK

PROPOSALS: FEEDBACK FROM THE OVERVIEW

AND SCRUTINY COMMITTEES

1. PURPOSE OF THE REPORT

1.1 To feedback the collective responses of the Scrutiny Co-ordinating Committee and the four standing Scrutiny Forums following their recent consideration of the Executive's Budget and Policy Framework Proposals for 2010/11.

2. BACKGROUND INFORMATION

- 2.1 At a meeting of the Scrutiny Co-ordinating Committee held on 16 October 2009, consideration was given to the Executive's Initial Budget and Policy Framework Consultation Proposals for 2010/11.
- 2.2 At this meeting it was agreed that the initial consultation proposals were to be considered on a service provision basis by the appropriate Scrutiny Forum. With any comments/observations being fed back to this meeting of the Scrutiny Co-ordinating Committee to assist in the formulation of this Committee's formal response, to be presented to the Cabinet on 14 December 2009.
- 2.3 Following the Cabinet's determination of their finalised 2010/11 Budget and Policy Framework Proposals at their meeting on 22 December 2009, further consideration was given to the finalised proposals by the Scrutiny Coordinating Committee at their meeting on 15 January 2010.
- 2.4 The Scrutiny Co-ordinating Committee and the four standing Scrutiny Forums then repeated the same process followed during the consideration of the initial budget consultation during 15 January 2010 to 26 January 2010, with collective feedback being considered at this meeting to enable a formal response to be determined and presented to the Cabinet on 8 February 2010.

- 2.5 During the consideration of the Executive's initial and finalised Budget and Policy Framework Proposals for 2010/11, the appropriate Cabinet Members were in attendance subject to their availability.
- 3. FEEDBACK FROM THE OVERVIEW AND SCRUTINY COMMITTEES TO THE EXECUTIVE'S FINALISED BUDGET AND POLICY FRAMEWORK PROPOSALS FOR 2010/11
- 3.1 As part of the Budget and Policy Framework consultation for 2010/11, Members of the Scrutiny Co-ordinating Committee and the four standing Scrutiny Forums considered pressures, priorities, efficiencies and potential sources of additional income for each of the authorities departments.
- 3.2 Based upon the evidence provided, comments made by the Scrutiny Coordinating Committee at its meeting on the 15 January 2010 in relation to the
 Councils overall budget situation, and specifically the Chief Executives
 Department, are outlined below. Given the timetable for submission of a
 formal Scrutiny response to Cabinet on the 8 February 2010, and access to
 information requirements for the publication of reports, the comments of each
 of the Standing Scrutiny Forums had not been formulated in time for the
 production and printing of this report. As such, full details of the Standing
 Scrutiny Forums comments will be circulated for Members consideration,
 under separate cover, prior to this meeting.
- 3.3 <u>Scrutiny Co-ordinating Committee</u> Members of the Scrutiny Co-ordinating Committee:-
 - (i) Strongly endorsed the protection of support for the Credit Union as a priority for 2010 and recommended that this funding be ring fenced;
 - (ii) Congratulated Cabinet in the decision to include the extension of the 'out of hours service' as a priority within the budget and policy framework proposals for 2010/11. Given that consideration of this area of the budget consultation proposals falls within the remit of the Neighbourhood Services Scrutiny Forum, Members strongly recommend to the Forum that:-
 - The extension of the out of hours service be supported and endorsed;
 and
 - The proposal, put forward by the Regeneration and Economic Development Portfolio Holder at the recent Cabinet meeting on the 22 December 2009, to extend the provision of noise abatement services to every Friday and Saturday evening be supported and endorsed as a cost effective means of expanding the service.
 - iii) Concern was expressed regarding the possible implications of the current, and future, budgetary position on staffing levels and the implications this could have on the capacity of staff, and in turn the authority, to respond to issues / queries (on an individual and strategic level). Emphasis was

placed upon the importance of having in place an appropriate strategy to help deal with any such possible loss of expertise and experience (i.e. training to enable the development of existing staff and recruitment / retention measures). Members emphasised the importance of Member involvement in the development of such a strategy through Scrutiny and Council.

4. RECOMMENDATIONS

- 4.1 It is recommended that the Scrutiny Co-ordinating Committee:-
 - (a) considers the feedback from the Authority's Overview and Scrutiny Forums' in relation to the Executive's Budget and Policy Framework proposals for 2010/11;
 - (b) determines its formal response in relation to the Executive's Budget and Policy Framework proposals for 2010/11 to be presented to the Cabinet on 8 February 2010; and
 - (c) grants delegated authority to the Chair of this Committee to approve the content of the formal response to enable its submission to the Cabinet on 8 February 2010 in accordance with the agreed timetable.

FUNDING

SUMMARY

1. PURPOSE OF REPORT

To seek Cabinet approval for Capital Programme proposals to be put forward to Scrutiny Co-ordinating Committee for their consideration.

2. SUMMARY OF CONTENTS

The report outlines the background to £1.2 million of funding available for capital programme works and presents proposals that have been prioritised by the Strategic Capital Resource and Asset Programme Team. It is suggested that Cabinet agree to forward the proposals to Scrutiny Coordinating Committee for their consideration in line with previous requests.

FUNDING

1. PURPOSE OF REPORT

1.1 To seek Cabinet approval for Capital Programme proposals to be put forward to Scrutiny Co-ordinating Committee for their consideration.

2. BACKGROUND

- 2.1 In February 2009 Members confirmed their commitment to Unsupported Prudential Borrowing for a range of local priorities which do not attract Government funding and to provide an annual allocation until 2011/2012 for asset management issues together with other items.
- 2.2 This is the area that Members can most readily exercise policy choices, albeit at a cost to the review budget, unless schemes can generate sufficient income in their own right.
- 2.3 Budget provision to fund the revenue consequences of the following prudential borrowing have been built into the budget process.

3. CONSIDERATIONS

- 3.1 Detailed proposals have been developed (see **Appendix 1**). In previous years these details have not been included in the detail budget proposals submitted to Scrutiny prior to consideration at Council. Following on from comments at Scrutiny, when the second quarter financial monitoring report was considered and bearing in mind that they are in intrinsic part of the budget and policy framework it is suggested that they be submitted separately for Scrutiny so that their views can be incorporated into the Cabinet's final budget recommendations to Council in February 2010.
- 3.2 Expenditure and commitments are reviewed throughout the year to ensure the full allocation is prioritised and spent.

3. RECOMMENDATIONS

3.1 That Cabinet approve the forwarding of the proposals to Scrutiny Coordinating Committee for their consideration.

*NOTE

There is an ongoing study regarding facilities at Seaton Carew and ultimately these items will be the subject of the outcomes of that study.

Window replacement at the Community Centre is an essential requirement to ensure service provision continues. The Sports Hall roof replacement is still the subject of review, and this scheme may be amended depending upon the outcome of the study. It is recognised that if the Sports Hall is to remain operational in the medium term some substantial works are needed.
