124. Minutes of the meeting held on 18 January 2010

These were confirmed as a true record subject to an amendment to item 120 Land at Graythorp relating to possible lease of the land. Members indicated that they had asked that leasing be the first option rather than selling, provided this were legally possible.

125. Invitation to Tender (ITT) Opening. Building Schools for the Future (BSF) Design and Build Contract – Sample School (Ref: 395) – Director of Child and Adult Services

A Preliminary Invitation to Tender (PITT) had been issued to six contractors on the Partnerships for Schools national framework and completed returns had been opened at the Committee on 29 June 2009. All four submissions had been evaluated and the results reported back to the Committee on 1st September 2009. At that meeting members had noted that two companies, Kier and Balfour Beatty, would be taken forward to the Invitation to Tender (ITT) stage. This invitation had subsequently been issued to the contractors on 4th

September 2009 with a submission deadline of 12 noon on 22nd January 2010. Both tenders had been received on time.

The Schools Transformation Manager advised that evaluation of the tender submissions would run from 26th January to 19th February 2010. There would be a formal public presentation of both tenders at the Borough Hall on Tuesday 2nd February, the Kier presentation would take place in the morning and Balfour Beatty in the afternoon. Members were invited to attend.
