53. Apologies for Absence

Apologies for absence were submitted on behalf of Councillors A Lilley and Wright.

59. Scrutiny Investigation into Hartlepool's Business Incubation System - Setting the Scene Report (Director of Regeneration and Neighbourhoods)

The Economic Development Manager submitted a report setting the scene for the Forum's investigation into the business incubation system in Hartlepool. The report outlined the reasons why Hartlepool needed to develop a more sustainable economy, the development of the DTZ PIEDA Business Incubation Strategy, development of funding mechanisms, integration of key partners, delivery of physical infrastructure and the implementation of the Business Support Framework.

In addition, the Economic Development Manager and Principal Economic Development Officer (Business Services) provided a detailed and comprehensive presentation which included the following issues:-

- Background and Historical Position
- Community Strategy Aim
- Challenges since 2000 lowest no of business start ups in Tees Valley, unemployment rate at 7.3%, 25% of adults of working age on state benefit, employment rate at 64.5%, changing inward investment patterns, global competition, declining historical engineering and manufacturing industries, reduced funding from Central Government and EU
- Strategic Development and Priorities DTZ Incubation Strategy (2002) main recommendations
 - Implementation of bespoke incubation system
 - Creation of enterprise 'Hot House'
 - Enhance existing managed workspace
 - Address shortage of move on accommodation
 - Development of partnership working framework
- Enterprising Hartlepool

Details and examples of businesses involved in group of local entrepreneurs

Following the conclusion of the presentation discussion ensued during which the following issues were raised:-

- (i) In response to concerns regarding the difficulties faced by small businesses in obtaining financial support, it was reported that whilst the Council did not have the resources to financially support all small businesses, there was a broad range of assistance available and the Council did promote the business rates relief scheme to assist with financial difficulties.
- (ii) In relation to access to grant funding, a query was raised as to why grants were limited or unavailable to the retail business sector. The Forum was advised that the Council were unable to support all businesses in the town. The types of support to retailers had generally been part of a broader strategy ie neighbourhood action plan work or business premises modemisation funding. Some of the difficulties in accessing funding were outlined which including the strict criteria in terms of eligibility for grant funding.
- (iii) In response to some concern regarding the recent initiative to encourage businesses to take up licences in the market place and the impact of this initiative on competition, the Economic Development Manager advised that of the 15 businesses who had been involved in the scheme, 10 had taken up licences in the Town, with a few more likely.
- (iv) The importance of businesses being able to access markets outside of Hartlepool and enable new businesses to flourish and grow was highlighted. Reference was made to the impact of other businesses outside the town on the local economy, the issue of duplication of businesses resulting in businesses struggling to survive, the need to close the gaps and the need to respond to changes with the markets. The Assistant Director commented on the value of liaising with Business Link to recognise established partners and minimising duplication.
- (v) Further discussion ensued on the grant system and eligibility criteria, the work currently being undertaken on the shop front

- parades, development of local partnerships and the work currently undertaken on promoting Hartlepool as a business location.
- (vi) A Resident Representative referred to access difficulties to pavements as a result of inappropriate parking by shop owners on shopping parades and commented on the benefits of the Council linking in with businesses to address this issue.
- (vii) A Member commented on the continuing demand for incubated business units and emphasised the benefits of development in disadvantaged communities.
- (viii) With regard to the loss of NRF funding in 2011 and the impact on the Council's delivery of services, a Member queried what strategy was in place to address this issue. The Economic Development Manager reported that work was currently underway on a future strategy to deal with the loss of area based grant funding.
- (ix) Following a request for clarification regarding the criteria for the Art and Culture Grant and whether this could be utilised to fund the art work on the disused platform of the railway station, the Scrutiny Support Officer agreed to explore this issue with the appropriate officer and respond to Members under separate cover.
