146. Minutes of the meeting held on 1 March 2010

147. 2010 IPSOS MORI Household Survey (Head of Performance and Partnerships)

The Strategy and Performance Officer outlined plans for the Hartlepool Partnership, Hartlepool Borough Council and Hartlepool New Deal for Communities (NDC) to commission lpsos Mori to undertake the 2010 The survey will measure the impact of the Household Survey. Neighbourhood Renewal Strategy and associated Neighbourhood Action Plans and provide data to measure 18 Local Priority Indicators within Hartlepool's Local Area Agreement. As Ipsos Mori had carried out the three previous surveys, this would provide comparable data... 900 face to face surveys will be undertaken at a total cost of £75,000 which would be funded from across the Hartlepool Partnership. Contributions from the Neighbourhood Element Fund and Working Neighbourhoods Fund had already been agreed by Council. The survey would commence in April 2010 with the results and national comparisons available in September 2010. The information would be used widely by the Council and shared with partners and the general public.

A Member queried whether there were facilities within the Tees Valley area to undertake the survey and was informed that the Joint Strategy Unit's Information and Forecasting Team provided a range of data that could be used alongside the household survey, but would not replace it. The Member also queried whether the Authority's Viewpoint Survey could be utilised to undertake the survey. Members were informed that because the Ipsos Mori survey would be taken face to face, answers could be followed up particularly in relation to quality of the environment and community safety. Members were informed that the data from the survey would be available to Members and disseminated to the Hartlepool Partnership and Neighbourhood Forums.
