1. PURPOSE OF REPORT

To obtain Portfolio Holder consent to allow a caravan club to operate on Seaton Carew Coach Park for ten days during the Tall Ships Race.

2. BACKGROUND

- 2.1 As Portfolio Holder will be aware the Tall Ships Race is coming to Hartlepool from 7th until 10th August 2010, and it is anticipated that there will be a very large number of visitors.
- 2.2 The Council has been approached by a Caravan Club wishing to site 150 caravans at Seaton Carew Coach Park (crossed hatched at **Appendix 1**) from 2nd until 11th of August to take advantage of this event.
- 2.3 Terms have been agreed with the caravan club and these are indicated in the financial implications section of this report.
- 2.4 Planning permission is not necessary for this proposal as the organisation is exempt under The Caravan Sites and Control of Development Act 1960.

3. FINANCIAL IMPLICATIONS

3.3 The decision to adopt a commercial approach to asset management requires the Council to realise the full value of any properties or property rights that it disposes of.


