The meeting commenced at 10.00 am in the Civic Centre, Hartlepool

1. Apologies for Absence

Apologies for absence were received from Councillors Reuben Atkinson, Sheila Griffin and Patricia Lawton.

2. Declarations of interest by Members

None.

3. Minutes of the meeting held on 31 March 2010

Confirmed.

4. Responses from the Council, the Executive or Committees of the Council to Final Reports of this Forum - Portfolio Holder's Response to the Investigation into 'Putting People First' - The Delivery of Personalised Adult Social Care Services (Director of Child and Adult Services and Portfolio Holder for Adult and Public Health Services

On 10 May 2010, Cabinet considered the Final Report of the Adult and Community Services Scrutiny Forum into 'Putting People First – The Delivery of Personalised Adult Social Care Services'. The Assistant Director of Commissioning was in attendance and provided feedback following Cabinet's consideration of, and decisions in relation to this Forum's recommendations. Submitted as an appendix to the report was the action plan approved by Cabinet providing details of the response and any proposed action in relation to each of the Scrutiny Forum's recommendations. Members welcomed the adoption of all the Forum's recommendations by Cabinet.

A discussed which included the following issues.

- (i) A Member sought clarification on the difference between Centres for Independent Living and Day Centres. The Assistant Director confirmed that Centres for Independent Living focussed around physical disability, hence the attachment to the Havelock Day Centre. The aim of Centres for Independent Living was to bring together a range of voluntary groups with a focus of promoting and encouraging independent living.
- (ii) A resident representative questioned how someone qualified to receive a personalised budget plan for the provision of social care. The Assistant Director confirmed that the eligibility criteria for the receipt of social care remained the same and anyone who meets the criteria was eligible for a personal budget.
- (iii) The level of satisfaction with the level of care provided at the day centres was questioned. The Assistant Director commented that through personal budgets, some people chose to do different things rather than attend day centres. However, the Assistant Director confirmed the commitment of the Council to maintain day services for people who chose to use them, although due to demand, this provision may be reduced.

Recommended

The report was noted.

7. The Role of the Adult and Community Services Scrutiny Forum (Scrutiny Manager)

The Scrutiny Manager submitted a report for Members' information which set out the role and remit of Scrutiny in general and specifically the Adult and Community Services Scrutiny Forum. Details of the scheduled meetings for 2010/11 were also set out.

The Scrutiny Manager indicated that all Members would be invited to attend an induction session which would look at all aspects of scrutiny responsibilities.

Recommended

The report was noted.

8. Determining the Scrutiny Forum's Work Programme 2010/11 (Scrutiny Manager)

The Scrutiny Manager reported that the Scrutiny Forum needed to develop a Work Programme for the 2010/11 Municipal Year, together with a timeframe for each review, for consideration by the Scrutiny Co-ordinating Committee on 23 July 2010. As such, the Director of Child and Adult Services, Cabinet Members for Adult and Public Health Services and Culture, Leisure and Tourism; Corporate Plan; and consultation with the Local Involvement Network had been the foundation sources for the report.

The following issues had been put forward for consideration as part of the forum's work programme for 2010/11:-

- Business Transformation Service Delivery Options
- Dementia Care
- Safeguarding Adults
- Broadband provision in Rural Areas

The Scrutiny Manager informed Members that consideration would also need to be given to the Budget 2011/12 and Departmental Plans along with the potential to consider any referrals received. It was therefore suggested that the forum may wish to consider limiting its investigations to one issue for 2010/11.

The Chair confirmed that as the Business Transformation would be considered by Scrutiny as the Service Delivery Options progressed, ideally

only one topic should be considered and as such, the safeguarding of adults was proposed. A discussion ensued on the other options included within the report and it was acknowledged that elements of dementia care would form part of the consideration of safeguarding adults.

The Scrutiny Manager confirmed that the scoping report for the investigation chosen would be presented to the Forum on 2 August 2010 with the work programme being submitted to Scrutiny Co-ordinating Committee for formal approval on 23 August 2010. Members were informed that further information on the topic chosen for investigation would be circulated to inform Members prior to the meeting to scope the investigation.

Recommended

That the Safeguarding of Adults be undertaken as the main topic for investigation during the 2010/11 municipal year.

Subject: SCRUTINY INVESTIGATION INTO SAFEGUARDING

OF ADULTS – SCOPING REPORT

1. PURPOSE OF REPORT

1.1 To make proposals to Members of the Adult and Community Services Scrutiny Forum for their forthcoming investigation into 'Safeguarding of Adults'.

2. BACKGROUND INFORMATION

- 2.1 At the meeting of this Forum on 5 July 2010, Members determined their work programme for the 2010/11 Municipal Year. The issue of 'Safeguarding of Adults' was selected as the Scrutiny topic for consideration during the current Municipal Year. Members suggested that this investigation should form the major in-depth Scrutiny Inquiry for the Forum's 2010/11 work programme.
- 2.2 In 2000, 'No Secrets: Guidance on developing and implementing multi agency protection of vulnerable adults' was introduced by the Department of Health.
- 2.3 No Secrets guidance described abuse as 'the violation of an individual's human and civil rights by any person or persons'. This right is underpinned by the duty, under the Human Rights Act (1998), on public agencies to intervene proportionately to protect the rights of citizen's, the guidance confirm that any intervention must not be excessive in comparison to the risk posed.
- 2.4 No Secrets guidance confirms that a multi-agency approach is required when investigating and intervening in order to safeguard and protect adults at risk of significant harm; with Social Services being the lead co-ordinating agency

- charged with the responsibility for ensuring, wherever possible, coherent and collaborative working.
- 2.5 The introduction of the No Secrets guidance also led to the creation of Adult Protection Committees and it emphasised the need for local procedures, coordination, collection and monitoring of data; including the identification of categories of abuse.
- 2.6 Hartlepool has a Vulnerable Adult Protection Committee, chaired by Officers from the Child and Adult Services Department and made up of a range of professionals and other stakeholders, who formally represent organisations in the statutory, independent and third sector. In order to safeguard and protect vulnerable people in Hartlepool, this Committee has a Safeguarding Action Plan which identifies action that should be taken to make improvements in safeguarding and protection of adults and it is used to monitor performance and measure progress made.
- 2.7 Hartlepool are also members of the Tees-wide Safeguarding Adults Board (TSVAB), whose function it is to ensure strategic policies and procedures and practices designed to prevent abuse and to promote the safety of vulnerable adults are developed. The Strategic Lead for Safeguarding and Vulnerabilities, and the Assistant Director of Operations, attend and represent Hartlepool Vulnerable Adult Protection Committee on this board.
- 2.8 The Tees-wide Safeguarding Adults Board has developed a work programme for 2010 to review Performance, Audit and Quality Assurance; Workforce Development and Training; Policy and Procedures; and Information Involvement and Engagement. It has been agreed that a Tees-wide Annual Report will be produced with input form each local authority.
- 2.9 In selecting this investigation, Members are keen to gain a clear understanding of how safeguarding services are provided in Hartlepool. In doing this Members are keen to identifying ways of improving or maintaining service provisions for the benefit of all. In order to facilitate this, suggestions for the terms of reference, potential areas of enquiry / sources of evidence and timetable for the investigation are outlined in Sections 4, 5 and 8 of the report. Member's views on these suggestions and the way forward for the conduct of the investigation are now being sought.

3. OVERALL AIM OF THE SCRUTINY INVESTIGATION/ENQUIRY

3.1 To explore and evaluate the provision of adult safeguarding services in Hartlepool.

4. PROPOSED TERMS OF REFERENCE FOR THE SCRUTINY INVESTIGATION/ENQUIRY

- 4.1 The following Terms of Reference for the investigation/review are proposed:-
 - (a) To gain an understanding of:-
 - (i) Legislation and policy relating to the provision of adult safeguarding services in Hartlepool;
 - (ii) The overall aim of the provision of adult safeguarding services in Hartlepool and what a positive outcome looks like.
 - (b) To examine how adult safeguarding services are currently provided in Hartlepool (including areas of partnership working) and explore their effectiveness;
 - (c) To gain an understanding of the challenges facing the provision of adult safeguarding services in Hartlepool, including demographic pressures and the increasing prevalence of dementia;
 - (d) To gain an understanding of the impact of current and future budget pressures on the way in which adult safeguarding services are provided in Hartlepool;
 - (e) To explore how the adult safeguarding services could be provided in the future, giving due regard to:-
 - (i) Improving the effectiveness and efficiency of the way in which the service is currently provided; and
 - (ii) If / how the service could be provided at a reduced financial cost (within the resources available in the current economic climate).

5. POTENTIAL AREAS OF ENQUIRY / SOURCES OF EVIDENCE

- 5.1 Members of the Forum can request a range of evidential and comparative information throughout the Scrutiny review.
- 5.2 The Forum can invite a variety of people to attend to assist in the forming of a balanced and focused range of recommendations as follows:-
 - (a) Member of Parliament for Hartlepool;
 - (b) Elected Mayor;
 - (c) Cabinet Member with Portfolio Holder for Adult and Public Health Services;

- (d) Director and / or appropriate officers of Child and Adult Services;
- (e) Independent Evidence (i.e. results / summary of the independent evaluation of the service);
- (f) Appropriate national/regional organisations and partner agencies
 - (i.e. Representatives from the Care Quality Commission, Tees-wide Safeguarding Board);
- (g) The Adult Protection Committee Board

(Membership of the Committee:- Hartlepool Borough Council officers, Police, NHS Hartlepool (Primary Care Trust), NHS Tees, Tees Esk & Wear Valleys NHS Foundation Trust, North Tees & Hartlepool NHS Foundation Trust, private sector provider representatives, Care Quality Commission, North East Ambulance Service, Hartlepool Local Improvement network (LINk), Cleveland Fire Brigade);

(h) Local residents and people who use services

(i.e. Hartlepool Local Improvement Network (LINk), Hartlepool Carers, 50+ Forum, Older Persons Local Implementation Team, Hartlepool Mental Health Local Implementation Team, Learning Disability Partnership Board, Life Chances Partnership Board, Community Network; Community Consultation Group, (this will also include the use of case studies as evidence));

- (i) Another Local Authority as an example of 'good practice' (i.e. Middlesbrough Borough Council);
- (j) Representatives of minority communities of interest or heritage (Expressions of interest to be sought from such groups through the HVDA [mailto:t.herrington@hvda.co.uk]; and
- (k) Ward Councillors.

At this stage no additional funding has been identified as being necessary to support Members in their investigation. Members, however, may wish to seek additional funding over the course of the investigation and the blank pro forma attached at **Appendix A** outlines the criteria on which a request to Scrutiny Co-ordinating Committee will be judged.

- (v) An overview of the services provided by the department (to be expanded in the next meeting).

(vi) Evidence (written or in person) from Mayor, MP and Portfolio Holder for Adult and Public Health Services.

 - A detailed overview of the services provided by the department;
