20. Minutes of the meeting held on 26 July 2010

These were approved as a true record.

21. Contract for the Provision of an Advocacy Service for Adults (Director of Child and Adult Services)

The Commissioned Services Manager informed Members that following the tendering process and evaluation of tenders received the contract had been awarded to DISC (Developing Initiatives Supporting Communities). The full process was outlined within the report. Whereas previously a flat fee had been paid in advance in the future a spot purchase arrangement would apply meaning the Council would only pay for services that had been used. These changes had been made due to difficulty ascertaining exactly how many people were using the service. Organisations had been asked to tender based on 200 referrals requiring 1500 client contact hours per annum. However this figure was pure speculation as the reporting mechanisms of the previous provider had failed to provide information on numbers of service users. Should this figure be incorrect the contract figure could be amended accordingly.

Members queried how the service would be monitored and were advised this would be done via a combination of the monthly report, regular inspections and an audit of the service. Members stressed the importance of contacting service users directly for their feedback however they queried whether DISC would charge the Council for provision of customer feedback surveys. The Commissioned Services Manager indicated that the rate was just to provide the service.

Decision

That the Director of Child and Adult Services' support of the views of the Commissioned Services Manager and the award of a contract for 3 years to DISC (Developing Initiatives Supporting Communities) to provide an advocacy service to adults with an option to extend due to satisfactory performance be noted.
