17. Scrutiny Investigation into the Working Neighbourhoods Fund – Scoping Report (Scrutiny Support Officer)

The Scrutiny Support Officer presented a scoping report for the Forum's investigation into the Working Neighbourhoods Fund

Aim of the Investigation

To assess the reduction and potential withdrawal of the Working Neighbourhoods Fund, its impact on the worklessness agenda and the options available for the continuation of service provision.

Proposed Terms of Reference

- (a) To gain an understanding of the overall aim of the services the WNF provides and what positive outcomes look like;
- (b) To examine how WNF services are currently provided in Hartlepool (including the input of partner organisations) and explore their effectiveness, particularly with regard to the worklessness agenda;
- (c) To determine the impact of the reduction and potential withdrawal of the Working Neighbourhood Fund;
- (d) To consider the options for the continuation of WNF service provision giving due regard to:
 - (i) How services could continue to be provided (within the

resources available in the current economic climate);

(ii) How services can be delivered more efficiently and effectively, particularly in relation to the worklessness agenda.

Potential Areas of Enquiry/Sources of Evidence

- (a) Member of Parliament for Hartlepool;
- (b) Elected Mayor;
- (c) Cabinet Member with Portfolio Holder for Regeneration and Economic Development;
- (d) Director and / or appropriate officers of Regeneration and Neighbourhoods Department;
- (e) Appropriate national/regional organisations and partner agencies;
- (f) Local residents and people who use services;
- (g) Representatives of minority communities of interest or heritage; and
- (h) Ward Councillors.

Key suggestions of documentary/internet sources were included in the report together with community engagement issues and details of the proposed timetable.

In the discussion that followed it was suggested that the proposed remit of the investigation should include the need to examine any future potential funding to maintain service provision and how such funding should be utilised.

With regard to the potential sources of evidence, the Forum were of the view that any local groups who had utilised the services should be invited to a future meeting of the Forum to share their experiences with the Forum.

A Member queried the Regeneration and Economic Development Portfolio Holder's availability to attend the meeting scheduled for Thursday 9 September 2010 at 3.00 pm and highlighted the benefits of rescheduling the meeting to Friday 10 September 2010 to accommodate the Portfolio Holder's attendance.

In terms of the proposed timetable for the investigation, it was agreed that an additional meeting be held on 25 November 2010 to determine the impact Government announcements would have on the Working Neighbourhoods Fund and options for the continuation of service provision.

Subject: WORKING NEIGHBOURHOOD FUND

1. PURPOSE OF REPORT

- 1.1 The purpose of this report is to provide a background and overview of the Working Neighbourhood Fund (WNF) programmes and:
 - (a) To gain an understanding of the overall aim of the services that WNF provides and what positive outcomes look like;
 - (b) To examine how WNF services are currently provided in Hartlepool (including the input of partner organisations) and explore their effectiveness, particularly with regard to the worklessness agenda;

2. BACKGROUND INFORMATION

- 2.1 On 30 November 2007, Communities Secretary Hazel Blears and the Work and Pensions Secretary Peter Hain announced a new drive to turn around long term unemployment in the most disadvantaged communities. Communities and Local Government (CLG) established the first-ever dedicated fund for local councils and community organisations to address worklessness, skills and enterprise and reduce levels of deprivation in the most deprived areas of the country. The Working Neighbourhoods Fund (WNF) was introduced in April 2008 and the fund replaced the Neighbourhood Renewal Fund (NRF) and incorporated the Deprived Areas Fund (DAF) to create a single discretionary fund for local authorities to work with their partners at a local level.
- 2.2 This announcement confirmed that the total WNF to be allocated to Hartlepool from April 2008 was £4,502,180 in 2008-2009, £5,378,345 in 2009-2010 and £5,589,121 in 2010-2011. Since 2008, each year approximately 60 projects have been approved by the Local Strategic Partnership (LSP) to deliver bespoke initiatives which have considerably improved economic growth and narrowed the gap within local areas. The projects have invariably contributed to all of the LSP themed objectives. For monitoring purposes, WNF programmes are split into each of the eight LSP themes and there is a Lead Themed Officer responsible for managing the performance of their



relevant themes (with the Economic Development Division responsible for the whole WNF package).

- On 10th June 2010, Hartlepool Council received confirmation from the new 2.3 Coalition Government that the Area Based Grant (ABG) was to be reduced by £1.662m. Unfortunately this meant that the WNF would have to be cut within this current financial year.
- 2.4 Cabinet made recommendations to Full Council on how to meet these ABG cuts which met on the 5.8.10. This report included recommendations on which WNF projects should have funding cut in this financial year. Full Council made the final decisions on each WNF project and the level of cuts to be made. The cuts to WNF amounted to a total of £716.000. This means that the revised budget for 2010/11 for WNF is now £4,930,049.
- 2.5 This unprecedented in year financial cuts and the anticipated cuts to public services means that there is no guarantee that WNF will continue/or be replaced beyond its end date of 31st March 2011. The Comprehensive Spending Review (CMR) will be announced on 20th October 2010 and this will provide a clear understanding if WNF will continue or be replaced.
- 2.6 If there is no continuation of WNF after this time or it is significantly reduced in funding then this will have a significantly adverse effect to the worklessness. skills and enterprise agenda in Hartlepool (and particularly for those residents and businesses from the most deprived wards). It will also be damaging to those organisations that are dependent on WNF in which to deliver their employment, training and business support programmes.

AREAS THAT THE WNF PROGRAMMES COVER 3.

- 3.1 Originally, Hartlepool's 2002 Local Neighbourhood Renewal Strategy used the government's Index of Multiple Deprivation (IMD) 2000 to established seven priority neighbourhoods within the town. The 2007 Index of Deprivation showed that some areas within the priority neighbourhoods identified in 2002 are no longer in the 10% most disadvantaged. However, because the way in which the Government calculates the index has changed significantly since 2000 and due to the long term vision of Hartlepool's 2002 Neighbourhood Renewal Strategy, those areas previously identified as a priority remained in the 2008 Strategy.
- 3.2 Alongside this, included within the 2008 list of priority neighbourhoods is the inclusion of Throston Grange, bringing the total number of priority neighbourhoods to eight. Although the 2007 Index of Deprivation does not place Throston in the bottom 10% overall, in the key areas of Employment and Health, Deprivation & Disability it is within the bottom 10% nationally. These themes are key priorities for the Hartlepool Partnership and as a result, it is considered appropriate to include Throston Grange in the list of the eight priority neighbourhoods (as shown below):

- Burbank •
- Dyke House/Stranton/Grange •
- Hartlepool NDC •
- North Hartlepool (Central Estate, Headland & West View/King Oswy)
- Owton
- **Rift House/Burn Valley** •
- Rossmere •
- Throston
- 3.3 55% of Hartlepool's population currently live in these eight priority neighbourhoods and the town has 17 wards of which 11 fall within the Neighbourhood Renewal area. Appendix 1 of this report highlights the current employment and key worklessness rates within each of the neighbourhood areas which is an indication of the ongoing challenges that are still faced.

4. JOBS AND THE ECONOMY THEME

- 4.1 At the request of the Scrutiny Forum, this report will concentrate on the WNF Jobs and the Economy Themed initiatives as the worklessness programmes are predominantly managed under this umbrella.
- 4.2 There are currently 66 WNF programmes being delivered in 2010/11 of which 27 are from the Jobs and the Economy Theme. Appendix 2 of this report gives a brief summary of each of these programmes, the project sponsor and the targets for 2010/11. Members are asked to note that there are other worklessness programmes under the Lifelong Learning and Health & Social Care which are shown within Appendix 2.
- 4.3 Overall, the 27 projects provide a raft of services including:
 - Engagement with hard to reach groups
 - Information, Advice and Guidance (IAG) Interviews •
 - **Regular Jobsearch facilities**
 - Self-employment and new business start up advice
 - Pre-employment programmes (including preparing for interviews)
 - Volunteering opportunities
 - Links to sector specific training
 - Grants and subsidies for residents to enter into employment and training
 - Intermediate Labour Market (ILM) placements
 - In-work mentoring and aftercare support
 - Pastoral support
 - Specialist support including mental health provision and benefits advice
- 4.4 All of these 27 initiatives contribute to the Council's nominated national and local priority Local Area Agreement (LAA) targets as shown below:

WHICH PRIORITY GROUPS DOES THE FUNDING TARGET? 5.

- 5.1 There are key priority groups living within the WNF areas that have been identified as being most at risk of being disadvantaged within the labour market. Therefore, the Jobs and the Economy Themed WNF is particularly targeted at the groups shown below:
 - Young people who are at risk of/or who are NEET
 - Young unemployed •
 - Long term unemployed .
 - Adults on incapacity or other sickness related benefits
 - Lone parents
 - BME community
 - Adults with caring responsibilities
 - Adults with no or low level skills
 - Adults with mental health issues or learning disabilities
 - People with disabilities and long term limiting illnesses
 - Ex Offenders
 - Adults at risk of becoming /or who are homeless
 - Adults with drug and alcohol misuse problems

WNF ALLOCATED TO THE VOLUNTARY AND COMMUNITY SECTOR 6.

6.1 As shown within Table A below, each year the Voluntary and Community Sector (VCS) receive approximately 40% of the overall WNF Jobs and Economy Theme budget.


- 7.3 It is worth highlighting that despite the significant impact that the global economic downturn has had at a local level over the past three years, the WNF providers have over-achieved on a number of outputs including numbers of:
 - New businesses assisted,
 - New businesses created.
 - Clients engaged,
 - Clients entering into training, volunteering; and;
 - Clients achieving a gualification
- 7.4 It is testament to the work of the WNF providers that projects have overachieved in a period when there has been fewer live vacancies and more people are losing their job/being made redundant. For instance, the WNF providers have been challenged with a substantial increase in the claimant count rate from 2,135 in May 2006 to 3, 791 in May 2010 (An overall increase of 44%). Fortunately, the claimant count now stands at 6.8% (July 2010). Furthermore, the number of live full-time vacancies has reduced by over 70% between June 2004 and June 2010. Between the period June 2008 to June 2009, the full-time vacancy rate reduced by 51% and the parttime vacancy rate dropped by 44% between June 2007 and June 2008.

8. HOW DOES THE WNF LINK TO OTHER RELEVANT INITIATIVES AND FUNDING?

8.1 REGIONAL EMPLOYABILITY FRAMEWORK (REF)

The Regional Employability Framework (REF) was designed to provide a framework through which partners are able to connect and deliver national priorities for economic development, employment, skills and neighbourhood renewal both at the regional. sub-regional level and local level. Implementation of this framework has allowed for the elimination of duplication, gaps and fragmentation that exists within current provision. The REF has lead to greater customer engagement; a consistent standard of service provision that is more responsive to client and employer needs; and greater and more sustained outputs and outcomes.

8.2 The Employability Service Model which all partners and projects across the Region are encouraged to follow is show below: -



- 8.3 The Department for Work and Pensions (DWP) and Skills Funding Agency (SFA) commissioning and tendering processes are increasingly requiring that all partners deliver employment and training activities in line with the REF journey. Alongside this, Hartlepool has reconfigured WNF to ensure that it follows the REF journey and compliments other external funding opportunities.
- 8.4 Through the creation of the REF model, it provides the WNF Jobs and Economy Themed projects with the ability to deliver all elements of the journey from initial engagement through to sustained employment. The WNF programmes have been commissioned which will add value to existing mainstream services available from agencies including JCP and Connexions.
- 8.5 The benefits of WNF are that it can be matched with a wide variety of funding streams including:

- Third Sector funding including Northern Rock, Comic Relief and Lottery • Funding
- European Social Fund (ESF) .
- European Regional Development Fund (ERDF) •
- Future Jobs Fund (FJF)
- SFA, i.e. Train2Gain
- Single Programme Funding
- 8.6 Hartlepool has fully maximised the matching of WNF with other funding streams and partners have been able to offer enhanced services to clients. For instance, the FJF project provides funding for eligible long term unemployed residents to enter into newly created employment for a six month period. To enhance this FJF offer, WNF was ring fenced which will provide almost 100 FJF clients with 13 additional weeks in their work placement (A total of 39 weeks in employment for 100 FJF clients). This will allow for these FJF clients to complete higher level gualifications.

OPPORTUNITIES FOR THE FUTURE 8.7

Economic Development has an excellent track record of securing external funding on behalf of the Council and third sector groups in Hartlepool. Economic Development has traditionally led on being the accountable for a wide range of externally funded employment, training and business support provision including Single Programme, ESF Objective 2 and 3 and DWP/SFA funding. The Division subcontracts a significant amount of this funding to the third sector and this work has created opportunities for the future (by providing VCS groups with a track record of delivering externally funded provision). Although funding will be restricted in the future, there are still significant opportunities as shown below.

8.8 NEW COALITION GOVERNMENT

The new coalition government is currently in the process of implementing major national policy changes to existing welfare to work and business support services. This means that the emerging Works Programme and Local Enterprise Partnerships (LEPs) will provide opportunities for local providers to tender for employment, training and business investment funding. Information on these opportunities is scarce at the present time, although Economic Development Division is working closely with key partners including Tees Valley Unlimited (TVU) to ensure that the town can capitalise on this funding.

8.9 **REGIONAL GROWTH FUND**

As part of the LEPs, the government announced a £1 billion Regional Growth Fund to help areas and communities at risk of being particularly affected by public spending cuts. The fund will be available in 2011/2012 and 2012/2013 and will help areas most dependent on public sector employment. This is to prepare areas for the governments drive to move towards an increase in private sector-led initiatives. Private sector and public-private partnerships will be able to bid for funding by demonstrating that their proposal will bring in private investment and support sustainable increases in private sector jobs and growth in their area.

8.10 DWP WORK PROGRAMME

Third sector groups could take full advantage of the emerging DWP Work Programme which will offer a single, personalised welfare to work programme for all client groups, delivered through contracted out provision.

- 8.11 The Government is aiming to have the Work Programme in place nationally by the summer of 2011 and will replace all national programmes currently on offer including the Young Person's Guarantee and Flexible New Deal.
- 8.12 The Work Programme will give providers longer to work with individuals and greater freedom to decide the appropriate support for them. It will offer significant new opportunities for contractors from the private and voluntary sectors to deliver flexible and personalised support.
- 8.13 Currently, DWP are inviting partners to submit expressions of interest to become prime providers. Economic Development Division via TVU Employment & Skills Board is aiming to work closely with these potential prime providers so that VCS groups in Hartlepool can take full advantage of subcontracting opportunities.

8.14 THE ASSOCIATION OF CHARITABLE FOUNDATIONS

The Association of Charitable Foundations (ACF) states that there are 8,800 independent grant-making trusts and foundations in the UK, giving £2.1 billion in grants to charitable causes each year. According to the ACF, trusts and foundations 'like to fund':

- new methods of tackling problems
- disadvantaged and minority groups which have trouble using ordinary services, or which are inadequately served by them
- responses to new or newly discovered needs and problems work which is hard to finance through conventional fund-raising
- one-off purchases or projects
- short and medium-term work which is likely to bring a long-term benefit and/or to attract long-term funding from elsewhere.

Traditional major grant funders for third sector groups include The Big Lottery which provides grants for health, education, environmental and charitable causes.

8.15 THE BIG SOCIETY

As part of the governments 'Big Society Agenda', there will be a new 'National Citizenship Service'. There will be initial flagship projects for 16 year olds to assist them to develop their skills to be responsible citizens, to mix with people from different backgrounds and to be actively involved in communities. Information on funding is scarce at the present time, although it is expected that there could be as much as £500,000 available for each project (To be confirmed). 9. ERS INDEPENDENT EVALUATION OF WNF (APRIL 2009)

- 9.1 The ERS Evaluation of WNF programmes was conducted in 2008/09 – with the final report published in April 2009. Overall, the evaluation highlighted that the majority of projects provided good value for money. The report recognised that due to the complexity of the client group that WNF providers worked with, it was important not to judge initiatives solely on their 'cost per job rate'. This was invariably due to the significant barriers that many clients faced in entering into work and their distance from the job market. Many of the projects provided first point of contact and engagement with hard to reach groups including people who were long-term unemployed and young people who are NEET.
- 9.2 The report acknowledged that the services were easily accessible to local residents' and that there was good spatial coverage of employment and training programmes across the WNF geographical areas. There was recognition that WNF providers had improved partnership working with key stakeholders across the town and that the WNF plugged gaps in mainstream JCP provision by offering day one eligibility for clients (some JCP provision is currently only available after a client is unemployed for six months).
- 9.3 There were high levels of satisfaction recorded with WNF clients who were interviewed and positive feedback on the services offered. There was acknowledgement that projects 'went the extra mile' for the client and provided very good pastoral support. There were areas for improvement identified including a need for some projects who worked with specific priority groups to work closer with statutory agencies including the Youth Offending Service and Connexions. Due to the economic climate, there was also a demand for projects to be reconfigured to ensure that increased levels of support for incapacity benefit claimants was made available to prevent them moving further away from the job market (including intensive mental health support services).

CASE STUDIES 10.

- 10.1 Appendix 3 provides three case studies of local residents who have benefitted from WNF provision. The case studies outline the client's history. barriers to work, support provided by the relevant agency and the positive outcome achieved. There are many case studies that could have been made available from the WNF providers. However, to give an overview of the diverse range of WNF provision offered to differing priority groups, the following projects have submitted case studies:
 - West View Project •
 - DISC STEP 'Homelessness' Project
 - Hartlepool Council, Economic Development Progression2Work

11. CONCLUSION

- 11.1 The report outlines that the overall WNF Jobs and Economy Themed activity has been successful and has offered positive outcomes for many local residents and new businesses and provided significant employment and training outputs. The WNF package is likely to be significantly reduced or cease beyond March 2011 and WNF providers who are dependent on this funding need to urgently consider what options are available to sustain and extend their activity.
- 11.2 WNF providers are in a good position to become subcontractors with large scale prime providers (due to their track record of delivering specialist services in deprived areas). This expertise should be fully maximised and WNF providers are being strongly advised by Economic Development to consider how best to place themselves as a subcontractor.
- 11.3 Economic Development will continue to work closely with key partners to ensure that the network of intermediaries across Hartlepool can take full advantage of these emerging opportunities.

WNF Case Study 1

Project Lead: Hartlepool Council's (Economic Development Department)

Project Title : Progression2Work

Client H had been referred to the Progression2Work (P2W) project as she had been on incapacity benefit for two years and wanted to move into sustained employment.

Client H had been suffering from depression and one of her son's had recently passed away which made matters worse. Alongside this, Client H other son was in prison so she didn't have any family around to support her.

The P2W Project Co-ordinator interviewed Client H and we discussed her past situation, her mental health issues and what she wanted to accomplish in the future. Client H stated that she wanted to work with young offenders. This was risky considering her personal tragedy and resulting illness. However, Client H was determined that she could succeed in this field of work as she wanted to make a difference to other families lives.

The Co-ordinator looked into agencies who work with young offenders in Hartlepool and after discussing the opportunities with Client H, it was decided to contact Hartlepool Borough Councils Youth Offending Team to ask about a placement. After an informal interview the HBC Youth Offending Team took her on a paid work placement – through ILM funding - for a minimum term of 26 weeks.

The Co-ordinator has provided ongoing intensive aftercare support for Client H to ensure that she sustains her work placement and as part of upskilling the individual, Client H in-work training package, she completed a Level 2 Introduction to Counselling course with Adult Education. Client H is now preparing to enrol for a foundation degree in "Working with Young People and People's Services" at the Hartlepool College of Further Education. The project is supporting Client H with buying course books.

Client H is still on the programme and is still on placement with the corporate youth offending team.

WNF Case Study 2

Project Lead: West View Project (WVP)

Project Title: West View Project

The young person used to attend the West View Project youth dub 7-8 years ago. She has now completed college gaining a Level 3 CASHE Diploma in Childcare and Education. Since leaving college, she has been unable to gain employment in either her chosen field of childcare, or anything else no matter how much she sent off CV's, application forms. She hadn't even managed to get an interview.

As the client used to attend WVP, she still knew some of the staff. She dropped into the centre one moming to see if there were any jobs available in the youth club. Unfortunately there weren't. We started to discuss what she had done at college and what she wanted work as. The dient advised that she had been hoping to get into a either a school as a teaching assistant or a crèche as a childcare assistant.

We looked at a few different websites to look for the jobs that she wanted and adjusted her CV so that it looked and sounded more professional. She saw 3 jobs straight away. She said that normally she would have never looked on these websites as she wasn't aware that they existed. We looked at the personal specifications for the jobs and she seemed the hit all the criteria for them. Again, the client said that she would have never done this. She applied for all 3 jobs, however she said that she always struggled with the personal statement. We sat and went through what needed to be in a personal statement, what the potential employers would be looking for and the importance of promoting yourself.

She managed to get an interview for 2 of the 3 applications forms she submitted. We looked at interview techniques, questions that could be asked and the answers that the potential employers would be possibly looking for. I even took her to one of the interviews as it was in Billingham and she had no way of getting over there.

Unfortunately she never got either job. What we did talk about is that this was a learning curve and to write the interview questions that she could remember and work out the best way to answer them when she is not under pressure. What we have also found over the years is that a West View postcode can work as a barrier for people when applying for jobs. This is something that with a good application form and good interview technique that we can overcome.

As well as the job searches, CV workshops, interview technique sessions, assistance on application forms and help with transport, I also looked at the confidence build and motivational side of why the client wasn't gaining employment. We set regular meetings to give her a routine which was lost when not at college or working and looked at aiming to build confidence with a number of outdoor activities. Through this, she has gained an RYA Powerboat level 1 qualification and experience in canceing and rock climbing.

A couple of months later and the dient was still applying for jobs when she applied for a job at Rossmere Sure Start as a Nursery Nurse. Again, I helped her with the application form. She got an interview and got the job. She is still there today, 7 months down the line.

WNF Case Study 3

Project Lead: DISC

Project Title: Step 'Homelessness' Project

Client D was referred to STEP by Hyped, DISCs Young Persons Drug Project. He was living with his family in an over-crowded house, the family had a long history of anti-social behaviour, drug use and unemployment. Client D had a history of drug use, mental health issues and had a history of offending; including burglary of a school, carrying an offensive weapon and handling stolen goods.

The Housing Support Worker helped Client D with a housing application and put a housing support package together, they arranged and attended accommodation interviews with him, providing housing related and emotional support. Client D was soon offered his own accommodation. His worker applied for grants, including a Community Care Grant and Frank Buttle which were both successful and helped him furnish his property. STEP also helped with utilities, sorting out his benefits and developing his budgeting skills.

The Training and Employment worker helped him to apply to the Future Jobs Fund resulting in him starting work for the Parks and Gardens Team. She also helped him with his transition into work, including accessing funding for work equipment.

Client D continues to successfully maintain his tenancy and has now been in employment with the Parks and Gardens Team for 6 months, is not using drugs and has not reoffended. Since his referral to STEP he has made progress in all areas of his life. He has also helped DISC with the making of marketing materials; becoming the face of our Christmas cards and some project leaflets. He has also sat on a panel of Managers to interview new members of staff for DISC; he has made a very valued contribution to DISC.

Client D has stated on many occasions that the STEP Project has helped to change his life.

Purpose of Presentation

Terms of Reference:

Background to WNF

- WNF replaced the Neighbourhood Renewal Fund (NRF) and incorporated the Deprived Area Fund (DAF) to create a single discretionary fund.
- The total WNF to be allocated to Hartlepool from April 2008 was:
 - £4,502,180 in 2008 2009,
 - £5,378,345 in 2009 2010, and
 - £5,589.121 in 2010 2011
- Approximately 60 projects each year.



ABG Cuts

- Reductions in 2010/11 grants are a precursor to more significant future government cuts.
- Chancellor's Emergency Budget on 22 June 2010 indicated non protected Government Departments face <u>average</u> cuts of 25% over 4 years from 2011/12.
- 2010/11 grant cuts total £3.556m, consisting of revenue grant cuts of £2.154m and capital grant cuts of £1.402m.
- In Year Cuts to Area Based Grant (ABG) at £1.662m
- Nationally ABG cuts 2%, locally it is 10%.
- Key Date 20th October 2010 (Comprehensive Spending Review)



Full Council Decision on WNF

- The Council was due to receive £16 million in ABG funding in the current year
- As stated, the government has reduced this funding by £1.662m.
- Individual authorities have the flexibility to determine how this cut is made.



Full Council Decision on WNF

- Council has sort to mitigate impact of grant cut on the town by using Temporary measures of £0.826m to partly offset the shortfall of ABG this year
 - Wasn't possible to protect all areas and
 - a longer term strategy needs to be found for 2011/12.
- Strategy approved by to full Council identified savings of £0.836m this year
 - Includes approved WNF cuts of £0.716m in this financial year.
- Also permanent reductions were approved , showing that from April 2011, cuts of £2.126m will be made to ABG
 - Includes WNF cut £1.587m (Indicative Budget would be £3.744m If WNF continues)




1. PURPOSE OF REPORT


