20. Apologies for Absence

Apologies for absence were received from Councillor Alison Lilley.

21. Declarations of interest by Members

The following Councillors declared a personal interest in minute number 26: Councillors Allan Barclay, Rob Cook, Kevin Cranney, Marjorie James, Trevor Rogan and Ray Wells.

22. Minutes of the meeting held on 12 August 2010

Confirmed.

23. Responses from the Council, the Executive or Committees of the Council to Final Reports of this Forum

None.

24. Consideration of request for scrutiny reviews referred via Scrutiny Co-ordinating Committee

The Chair informed Members that a request from Scrutiny Co-ordinating Committee had been received to review item RN 34/10 from the Forward Plan: Housing Adaptations Policy for 2010-2013. It was noted that this issue was cross-cutting across the Adult and Community Services, Children's Services and this Scrutiny Forum and it was suggested that an additional joint meeting be arranged to enable full consideration of this review to take place.

It was agreed that an additional joint meeting would be scheduled and a letter would be circulated to Members confirming the date, time and venue.

Recommended

That a joint meeting of the Adult and Community Services, Children's Services and Regeneration and Planning Services Scrutiny Forums be scheduled to consider the referral from Scrutiny Co-ordinating Committee on the Housing Adaptations Policy for 2010-2013 and details confirmed in writing to Members.

25. Consideration of progress reports/budget and policy framework documents

None.

26. Scrutiny Investigation into 'Working Neighbourhoods Fund' – Setting the Scene (Scrutiny Support Officer)

The report set the scene for the Forum's investigation into the Working Neighbourhoods Fund in Hartlepool. The report outlined the Working Neighbourhoods Fund, its programmes, achievements and the areas of the town and groups it covered.

In addition, the Economic Development Manager and Employment Development Officer provided a detailed and comprehensive presentation which included the following issues:-

- Reductions in Area Based Grant (ABG)
- Areas covered by WNF Programmes and the challenges faced within

these areas

- The link and outputs achieved for Jobs and the Economy theme from the Community Strategy
- Priorities for funding
- Allocations to the voluntary and community sector
- Links to other relevant initiatives and funding
- Opportunities for the future
- Independent evaluation of WNF
- Case Studies
- Conclusion

A discussion ensued which included the following issues.

- (i) A Member questioned when the actual WNF outputs achieved for the Jobs and Economy theme would be available for the first quarter of 2010/2011. The Employment Development Officer confirmed that unfortunately the detail was not available at the time of the report being printed for this meeting but that information was available now if required.
- (ii) An individual case study was referred to which had enabled a young man to progress through the Future Jobs Programme and had resulted in him living independently, running his own affairs and considering self employment. This highlighted that opportunities for young people to gain employment through programmes such as the Future Jobs Fund, with the appropriate support in place, had proven successful.
- (iii) In response to a question from a Member, the Director of Regeneration and Neighbourhoods commented that Hartlepool was the only district in the region working towards a replacement for the WNF being established. This was based on the fact that budgets would include some of the former WNF and Area Based Grants (ABG) funding and would be unringfenced to enable Council's to decide what areas were funded.
- (iv) The report referred to WNF providers becoming sub-contractors with large scale prime providers and a Member questioned how this was being progressed. The Economic Development Manager confirmed there would be a series of activities looking at this and there were already well established links and good partnerships in place with the current providers. Discussions had already taken place with potential prime providers and this would be an ongoing process.
- (v) A Member commented that the Voluntary and Community Sector had a track record in achieving match funding for projects and it was suggested that once the Comprehensive Spending Review was announced, additional support be provided to this sector to ensure that applications for match funding were maximised to boost the grant aid for the town wherever achievable. The Director of Regeneration and Neighbourhoods confirmed that it would be early in 2011 before the detailed information on the budgets would be available.
- (vi) The number of jobs that were potentially at risk through the withdrawal of WNF was questioned. The Employment Development Officer estimated that around 60-70 jobs were at risk across the WN projects.

- However, this number needed to be substantiated as the Development Officer was not convinced that all of the WNF providers had been clear about the actual jobs that may be affected. This was currently being reviewed.
- (vii) A Member sought clarification on how value for money was determined against each project. The Director of Regeneration and Neighbourhoods commented that it was difficult to quantify value for money across this programme as the affects could range from supporting a disabled person, unemployed for 10 years to gain employment as a result of this programme against someone made redundant and in a new job after only 3 months. The Economic Development Manager added that a calculation had been done which indicated that someone who was long term economically inactive would cost around £72k.
- (viii) The Director of Regeneration and Planning Services commented that Members should be mindful that the Economic Development Team had a proven track record of achieving funding from many different areas over the years. He added that the Tees Valley Local Enterprise Partnership submission was one of the first to be submitted and should result in funding being made available as a recent Government survey had highlighted Hartlepool, Redcar and Middlesbrough as the three worse towns to be affected by the recession.
- (ix) A Member commented that although it was acknowledged that Hartlepool did lead the way in relation to the workless agenda, it had been said that there was a lot of duplication across the many organisations/providers within the town. The Economic Development Manager confirmed that as part of the current review of budgets, the Corporate Management Team had requested that a range of programmes were examined, especially in relation to duplication with a suggestion of organisations coming together to reduce overheads, possibly through the merging of back office functions or simply sharing a building. As part of this review, organisations were being asked to show what they had done to ensure that the future of their organisation was sustainable.
- (x) In response to a question from a Member, the Assistant Director (Regeneration and Planning) confirmed that since his recent appointment, the reception from organisations and people both within and outside the Council had been very enthusiastic with a spirit of cooperation and willingness and despite the current economic climate, he felt that Hartlepool had a lot to be positive about.

Members were asked to note that a number of people from other organisations had expressed an interest in participating in this enquiry and the town's MP; lain Wright would be making a written submission. In addition, it was noted that the Portfolio Holder for Regeneration and Economic Development would be in attendance on 14 October 2010 to participate in this enquiry also.

Recommended

That the information given be noted and the comments of the Forum and evidence provided be used to assist with the scrutiny investigation.

27. Six Monthly Monitoring of Agreed Regeneration and Planning Services Scrutiny Forum's Recommendations (Scrutiny Support Officer)

Details of progress made on the delivery of the agreed scrutiny recommendations against investigations undertaken by the Forum since the 2005/06 municipal year were presented to Members. The report included a chart which provided the overall progress made by all scrutiny forums since 2005 and Appendix A provided a detailed explanation of progress made against each recommendation agreed by this Forum.

It was noted that since the 2005/06 municipal year, 85% of the Regeneration and Planning Services Scrutiny Forum's recommendations had been completed with 7% assigned and 8% overdue.

Members were requested to retain the plastic wallet folders provided to them enclosing the six monthly update report and were asked bring them to future meetings where progress reports were to be considered.

Hart Gables Gaymes 2009/2010

Hart Gables was set up more than 10 years ago to support lesbian, gay, bisexual and transgendered (LGBT) people. It is a registered charity and remains the only organisation in Hartlepool that offers support for LGBT people.

The organisation is run by a Management Committee of lesbian, gay, bisexual and transgendered people living in and around Hartlepool, which is supported by advisors from a range of helpful local agencies.

Hart Gables provides a range of services for those questioning their sexuality or gender.

There is a regular mixed group and a group specifically for our transgender community.

There is a counselling service, and you can access trained listeners on the telephone or in one-to-one sessions at our base on South Road.

The main aims of Hart Gables are:

- To provide a regular safe space for the LGBT community
- To involve the community in the development of the organisation as much as possible
- To support the community in building social networks
- To work with other LGBT organisations in the region & nationally
- To build confidence of individuals in the community
- To work with other outside individuals & agencies who support the values and aims of Hart Gables

- To provide access to sexual health information
- Hart Gables employs lesbian and gay workers who can offer training on a wide range of sexual health, equality and social inclusion issues. This can often be provided free or for a nominal fee to
- To provide a free, confidential, impartial
 & non-judgmental listening service
- Voluntary and Community Sector groups and organisations, and reasonable fees for statutory sector organisations.



The Gaymes 2009

This year over 150 people took part in The Gaymes which was held at Brierton Community Sports Centre on Sunday 6th September. Even though the weather was a very changeable, we had rain, wind and then a little bit of sunshine. Everyone that attended had a really good and fun time.

There was a range of activities including, alternative therapies such as, reflexology, massage, facials, eyebrow waxing and Indian massage. 30 people enjoyed one or more of these therapies. There were stilt walkers, bungee running, a bouncy castle and Mr Dan of Manhattan Heights. The disco also went down a real treat.





Overview of Funding

Gaymes 2009

The WNF funding was received in 2009 we used this money to promote and fund the annual "Gaymes" event which was in its third year. This event helps break down the barriers for the LGBT, (lesbian, gay, bisexual, and transgender) and brings the community together.

At the event in 2009 we highlighted "Hate Crime" raising awareness of homophobic/transphobic hate crimes. The gaymes was a good way of getting the message across to a diverse range of people who we may not often reach. We had people from Newcastle entering teams as well has the local youth service, police, community police and HVDA. This alone makes a great difference in breaking down the stigma of LGBT community.

The funding has enabled people to have better life chance through being able to get involved and becoming a volunteer at Hart Gables, we have 5 full time volunteers who have engaged in NVQ training. Jynx one of our younger service users has just completed his NVQ level 2 and is going on to business admin level 3, this has built confidence within himself and helped him deal better with his disability.

Without this funding we would find it hard to reach people like Jynx and to tap into other areas.

This year's event was a little different we worked in partnership with the Rift House Residents Association; I worked with Christopher Akers-belcher to create this family fun day. Hart Gables hosted "it's a knockout" competition and there were over 300 people at the event.

Hart Gables also offering a service in Stockton which is for LGBT 25's and over it's called "Choices" it is funded by Stockton PCT this project started in December and finishes December 2010.
