## 230. Corporate Plan (BVPP) 2006/07 (Assistant Chief Executive)

The report set out the draft Corporate Plan (BVPP) for 2006/07. The plan was submitted to Cabinet earlier in the week and there were no additions or amendments suggested. The Scrutiny Co-ordinating Committee had received an early draft of the Plan on 24<sup>th</sup> February and had agreed the general themes for inclusion.

Officers across the Council had been working and drawing together the key Performance Indicator information for inclusion within the Plan. This information was shown under each of the Corporate Plan sections attached by way of an Appendix. The remaining non-key Performance Indicator information was also included where available, although by necessity, some Indicators would not be available until June.

There was a statutory requirement to publish the final Corporate Plan by 30<sup>th</sup> June and as the Plan formed part of the Policy Framework, final approval would rest with full Council.

Members were concerned that some of the Performance Indicator information was unavailable, particularly the financial information. Officers indicated that this information would not be available until early June.

The Committee went on to consider the Corporate Plan 2006/07 dealing with each of the sections based around the community strategy themes separately. In relation to each of the individual sections, Members made the following comments as detailed below:

## Jobs and the Economy

- Under the jobs and economy theme (Ref JE1), Scrutiny Co-ordinating Committee queried the accuracy of measuring new business start-ups according to VAT registrations. A Member suggested that form CWF1, which is used to register businesses with the Inland Revenue would be a more accurate tool by which to measure small business start-ups.
- Officers accepted that VAT registrations are not the most accurate method by which to measure new business start-ups however, the approach adopted reflected one used nationally. Members were informed that locally, this issue has been highlighted with GONE (Government Office North-East) and the Inland Revenue and is in the process of being reviewed. Meanwhile, the committee was informed that proxy measures are in place to ensure an accurate record of business start-ups is maintained.
