#### Type of decision

#### **Purpose of report**

To seek approval from the Portfolio Holder for the Waverley Allotments Project to extend their current set up at Waverley Terrace.

#### Issue(s) for consideration by Portfolio Holder

The Waverley Allotment Project had asked if it would be possible to extend the site they currently occupy to utilise adjacent vacant land susceptible to fly tipping. A map was appended showing the proposed extension. Parks and Countryside had raised no objection. It was proposed that the last be handed over rent-free for 3 years. During that time Waverley Allotments Project would be responsible for repairs and running costs. They would also be required to seek planning permission for this proposed use and for any future structures at their own cost.

The Portfolio Holder was happy to approve the extension, describing it as a brilliant scheme which would bring unused land back into use. He was impressed at the funding which the Project had managed to secure from organisations including the Crime and Disorder Partnership, Pride in Hartlepool and Communities Health Funding.

#### Decision

That the extension of the Waverley Allotment Project onto land at Waverley Terrace within the Council's ownership be approved under the terms proposed in section 3 of the report.
