## 20. Social media promotions of stray dog rehoming service (Assistant Director, Neighbourhood Services)

#### Type of decision

#### Purpose of report

To provide the Portfolio Holder with information regarding the use of social media to promote the Council's stray dog rehoming service.

#### Issue(s) for consideration by Portfolio Holder

Part of the current dog warden service involves the rehoming of stray dogs. This service is promoted via the Council's website, posters in vets and pet shops and via roadshow events. Articles also regularly feature in Hartbeat. It was proposed to extend promotion of this service through use of a dedicated Facebook page. This would be maintained and updated by the admin team within the Waste and Environmental Services Section. Photos of dog collected by the service would be uploaded onto the page together with a brief description of the dog thereby enabling dog owners to identify whether their lost dog had been posted on the site. There would also be the facility for users to post pictures of their lost dogs on the site. These could then be checked against any new dogs collected by the dog warden. Information on micro chipping surgeries, neutering campaigns and other responsible dog ownership messages could also be posted on the site. Additional costs would

be minimal and there could be a potential savings in kennel fees through reuniting or rehoming dogs more quickly.

The Portfolio Holder was pleased to note the proposals saying anything which reduced costs to the Council should be pursued.
