Members were advised that a number of tenders had been received which were incorrectly marked, either wrongly addressed or without sufficient information to identify which contract was being tendered for. Members gueried why their previous request that an addressed envelope or address label be included within all tender packs had not been adhered to. The Estates and Valuation Surveyor advised that he had been unaware of this requirement. Members were concerned to learn that despite all their previous comments and requests there was still an apparent lack of clarity regarding correct procedures for the return of tenders. The Procurement Officer commented that with the move toward electronic tenders these problems would not occur. Nevertheless the Chair indicated he would write to the Assistant Director (Resources) expressing the concerns of the committee and asking that in the future officers be advised that all tender packs should include an addressed envelope or address label. Given the incorrect receipt of tenders appeared to be a failing on the part of officers rather than the tenderers and all tenders had been received on time Members agreed that all the tenders be accepted and opened.
